



GENERAL TERMS & CONDITION FOR CONTRACTUAL ENGAGEMENT UNDER NHM, MALKANGIRI

1. Applicant must be a citizen of India.
2. The above positions are purely temporary, co-terminus with the scheme and may be terminated at any time without assigning any reason thereof. Canvassing in any form will render the candidate disqualified for the position.
3. Details of vacancy, eligibility; age, application form etc. can be downloaded from the Malkangiri District Web Portal (www.malkangiri.nic.in).
4. Candidates are required to apply in prescribed format available in the website www.malkangiri.nic.in and to submit along with a set of self attested copies of all certificates in support of age, qualification, experience, residence etc. Candidates are also required to submit two recent passport size colour photograph, and ID proof (Voter ID/ PAN/ Driving License/ Passport/ Aadhar Card) and valid Residence & Caste certificate issued by the competent authority on the date of interview.
