- Bidders should remit the Cost of Tender Paper and Earnest Money Deposit through NEFT/RTGS payment using internet banking of the bank in which the bidder holds his account, by adding the account number as mentioned in the challan as an interbank beneficiary.
- Bids received on line on due date and on time shall be opened at **11.00 Hours on 03.08.2019** in the office of **Executive Engineer, RWS&S Division, Malkangiri** in the presence of the bidders or their authorised representations who wish to attend. Bidders can witness the opening of bids
