



In inviting reference to the subject cited above, I am directed to intimate that the District Legal Services Authority, Malkangiri invite application from interested literate persons (preferably matriculate) from various section for their selection and engagement as Para-Legal Volunteers (PLV) under District Legal Services Authority, Malkangiri on honorarium basis for a period of one year. The selected persons will undergo a Training Session. The duty of Trained PLVs includes;

- ✓ To act as a bridge between the needy people and Legal Services Institution;
- ✓ To generate awareness regarding activities of Legal Services institutions;
- ✓ Extend care and support to victims of crime;
- ✓ To keep watch on injustice, report crime against children;
- ✓ To educate and aware the people relating to their legal rights etc.

In this connection, I am to further inform that, **the work of PLVs does not carry any salary, remuneration or wages except honorarium of Rs.500/- per day for specific assignments** to be entrusted to him/her on different occasions.

Para Legal Volunteers are to be identified from the following target groups.

- Teachers (including Retired Teachers)
- Lady Teachers.
- Retired Government Servants and Senior Citizens.
- Anganwadi Workers.
- Doctors/Physicians.
- Students & Law Students (till they enroll as Lawyers)
- Members of non-political, Service oriented NGOs and Clubs.
- Members of Women Neighborhood Groups, Maithri, Sanghams and other Self-Help Groups including of marginalized/vulnerable groups.
- Educated prisoners with good behavior, serving long term sentence in prisons.

Therefore, I request you to expedite in sending a list of interested and dedicated members for their engagement as PLVs on or before **22.07.19** positively for taking further necessary action at this end.

Further, you are requested to **display the sample format (copy enclosed) in the Notice Board of your respective office/institution** so as to enable the interested and dedicated members to submit their application, if so desired, directly to this authority for the above purpose.


