## NOTICE

As per "Regulatory Guideline for Hostels of Educational Institutions for Children" developed by the National Commission for Protection of Child Rights (NCPCR) all hostels are running in educational institutions whether run by State Govt. or Non Governmental Organization (NGO) are mandatory to be registered under the District Education Officer to ensure the safety and security of the children and to protect their rights in hostel premises.

- After the enforcement of the guideline by notification of NCPCR, no Hostel of Educational institution shall run for children without registration. [U/S 02(12) of the Juvenile Justice (Care & Protection of Children) Act, 2015 child means a person who has not completed 18 (Eighteen) years of age.]
- The Head of such Institutions are advised to submit written application in the prescribed format (developed by NCPCR for grant of Hostel registration) to the District Education Officer, Malkangiri **on or before 31<sup>st</sup> January 2020**. The Application form and Guidelines are available in the web portal of National Commission for Protection of Child Rights (NCPCR) i.e. <https://ncpcr.gov.in>.
- The organizations, which fails to apply for registration by 31<sup>st</sup> January 2020 liable for prosecution as per law. Housing of children in unregistered Residential Hostel will be treated as illegal confinement and legal action as deemed proper shall be initiated against such organization.
- If, the Hostel of Educational Institution is run, managed or established by the Govt. (Centre or State), and the competent authority is involved in establishing/managing/running such hostel, there is no need to apply for registration.
- If any query, the Head of the institutions may contact with the District Education Officer, Malkangiri.
