OFFICE ORDER

Sub: - Circulation of tentative Gradation List & Rejection list of AWWs as on 01.01.2020 having Matriculation as qualification with 10 years of experience – Inviting of objections.

In pursuance of the Letter No. 7768 dated 20.05.2016 of Govt. in W&CD Department, Odisha, Bhubaneswar and basing on the information submitted by the C.D.P.Os of Malkangiri district in respect of A.W. Workers the tentative Gradation List of AWWs as on 01.01.2020 who have completed minimum 10 (Ten) Years of Service and having Matriculation Qualification or above is hereby prepared and attached herewith as Annexure-I and the Reject list in Annexure-II. The gradation list is prepared in the following manner:

1. The tentative Gradation List of 143 ( One Hundred Forty-three) AWWs who have worked as Anganwadi Worker for 10 years and completed matriculation found to be eligible in terms of eligibility criteria are enlisted in Annexure-I.
2. Draft List of 126 Nos (One Hundred Twenty-Six)AWWs are enlisted in Rejection List i.e. Annexure-II citing the reasons of rejection who are found to be ineligible as per the records submitted. Grand Total-269 AWWs.

The tentative gradation list of the eligible A.W.Ws in Annexure-I and Reject List in Annexure-II is circulated herewith among all the A.W. Workers of the district through their concerned CDPOs prepared after due scrutiny, inviting objections, if any, to be submitted through the concerned C.D.P.Os on or before 21.12.2020. No communicated in this regard will be entertained after 21.12.2020.

The AWWs willing to file objection should submit authentic documentary evidence along with their objection. Objection received after due date/ not accompanied with requisite documents will not be considered.



**Proceeding of the Meeting of the Scrutiny Committee held on 04.12.2020 for preparation of final gradation list of AWWs for the year 2020 (as on 01.01.2020)**

The Verification Committee Meeting for preparation of District level Common Gradation List of matriculate Anganwadi Worker with 10 years of experience as AWW was held on 04.12.2020 at 10.30 AM in the office of District Social Welfare Officer, Malkangiri. The following members attended the meeting under the Chairmanship of Sub-Collector, Malkangiri.

1. Sub-Collector, Malkangiri – Chairman
2. D.S.W.O, Malkangiri – Member-Convener.
3. Dist. Welfare Officer, Malkangiri – Member
4. Dist. Social Security Officer, Malkangiri- Member
5. All CDPOs of Malkangiri Dist

After welcoming all members present in the meeting Sub- Collector, Malkangiri wanted to know the modalities and implantation of Govt. guidelines as regards preparation of Gradation List AWW. The following records /documents as regards passing of 10<sup>th</sup> by the A.W. Workers i.e. mode of passing such examination for in-service candidates, Genuineness of the Caste Certificates in case of A.W. Workers belonging to SC/ST/SEBC category, date of joining with reference to the appointment order were placed before the committee.

The D.S.W.O., Malkangiri appraised before the committee about the details of guidelines issued by the Govt. in WCD&MS Department, Odisha, Bhubaneswar as regards preparation of common district gradation of eligible A.W. Workers for consideration of selection to the rank of Supervisors. She appraised before the committee and also produced the clarification received from Govt. vide letter No. 7768 dt. 20.05.2016, Letter No.11454 dtd. 22.07.2016, Letter No. 4213 dt. 03.03.2014 and Lr. No. 12187 dt.30.07.2016 Notification No.2990 dated 21.02.2019 and Notification No.2995 dated 21.02.2019 .

As per clarification communicated by Govt. vide Letter No.11454 dated,22.07.2016 of Additional Secretary to Govt., W & CD Department, AWWs completed ten years of qualifying service and having matriculations (HSC) qualification as on 01.01.2016 are eligible to be enlisted in the common gradation of the district for consideration of selection to the rank of ICDS lady Supervisor. As per clarification communicated vide Letter No11454dated.22.07.2016 of Govt. in WCD & MS Department, Odisha, Bhubaneswar, A.W. Workers who have passed HSC or equivalent examination while in service and completed 10 years of service as such is eligible for empanelled in the gradation list, keeping in view of her date of joining as A.W. Worker. provided she has to acquire the required qualification as on 01.01.2020.

The HSC certificate and Caste certificates of the Anganwadi Worker in case of SC/ST/SEBC A.W. Workers, having 10 years of experience as A.W. Worker were thoroughly scrutinized by the committee keeping in view to the eligibility criteria and documents furnished by the AWWs through CDPOs.

The following modalities are decided to be adopted so as to ensure fair implementation of the Govt. guidelines for preparation of gradation list of the eligible AWWs.

1. She should have matriculation / HSC qualification with 10 years of experience as AWW as on 01.01.2016.
2. As per G.O No.4213 dated 03.03.2014 of Govt. in W & C.D Department, Odisha, Bhubaneswar that the permission is not mandatory but she has to intimate about appearing and passing of the examination being in service. Hence it is decided by the committee that serving A.W. Workers taken leave to appear the H.S.C examination in distance / private / Ex-regular mode will be considered as valid.
3. Since date of joining as A.W. Worker is most important to prepare the gradation list, Sub-Collector, Malkangiri –cum-Chairperson directed all the CDPOs of the CDPOs to submit authentic joining report as A.W. Worker and if joining report is not available then office records / documents to produce before the Committee for acceptance her joining as A.W. Worker.
4. AWWs who have submitted matriculate/HSC certificate from different board other than BSE (Odisha) are supposed to submit the certificate equivalent to the list notified under Notification No-252 dated.5.08.2014 & Resolution No-06 & 07 dated.17.05.201 of B.S.E, Odisha to taken as valid. It is decided by the committee that the AWWs Matriculation Certificate of institutions which are not enlisted in the equivalency list issued by the Govt. of Odisha (BSE, Odisha) vide letter no.252 dated 05.08.2014 will not be considered for inclusion in the valid tentative Gradation list.

The verification committee gone through the service particulars and details information pertaining to the service particulars of AWWs received from the C.D.P.Os. The committee revealed that CDPOs have communicated list of 269AWWs who have completed ten years of service and claimed to have passed matriculation. The gradation list in order of seniority is to be prepared basing on their date of joining as A.W.Workers and in case of same date of joining by two or more A.W. Workers, their date of birth will be taken into consideration as per the guidelines of Govt.


Hence after thorough discussion and after going through the records copies of certificate and documents of individual A.W. Workers, the committee members decided to prepare the Tentative common Gradation List of A.W. Workers in the following manner:


1. The tentative Gradation list of 143 ( One Hundred Forty-three) eligible A.W. Workers as per **Annexure-I** of different projects was prepared for publication inviting objections if any within a period of 15 days i.e. latest by 21.12.2020 from the concerned A.W.Ws through the CDPOs.
2. The list of A., W. Workers whose documents are found to be doubtful by the committee as per the modalities of verification and scrutiny need to be kept in the Reject List that is subject to modification on production of authentic documents within the period of objection period i.e. by 21.12.2020. Any objection / documents received after 21.12.2020 shall not be taken into consideration after 21.12.2020. Accordingly as per the decision of the Committee 126 Nos (One Hundred Twenty-Six) A.W. Worker are placed in the Reject List i.e. **Annexure-II** with the grounds of rejection in the Remark column.


3. The Sub-Collector, Malkangiri-cum-Chairperson directed all the C.D.P.Os present in the meeting to submit the requisite documents / information in respect of the A.W. Workers with their authentication if any before the last date i.e. by 21.12.2020 keeping in view of the information in the Tentative Gradation List.


