



Proceeding of the Meeting of the Scrutiny Committee held on 22.12.2020 for preparation of Final Gradation List of eligible AWWs for the year 2020

The Committee Meeting for preparation of District level Common Gradation List of matriculate Anganwadi Worker with 10 years experience as AWW was held on 22.12.2020 under the Chairmanship of Sub-Collector, Malkangiri in his Office Chamber.

The following members attended the meeting


1. Sub-Collector, Malkangiri – Chairman
2. D.S.W.O, Malkangiri – Member-Convener.
3. Dist. Welfare Officer, Malkangiri – Member
4. Dist. Social Security Officer, Malkangiri- Member
5. All CDPOs of Malkangiri Dist – Members.

At the outset the Sub- Collector, Malkangiri welcomed all the members and asked the District Social Welfare Officer, Malkangiri to brief the details of meeting.

The D.S.W.O, Malkangiri apprised that the Tentative Gradation List approved by the committee prepared as per the modalities fixed with reference to the guidelines of Govt. in WCD & MS Department was circulated among all the CDPOs of the district and all concerned vide Letter No-1831 Dated.07.12.2020 inviting objections if any of the A.W. Workers within 21.12.2020.

The modalities adopted to prepare the Tentative Gradation List keeping in view to the eligibility criteria are as follow:

1. One should have matriculate / HSC qualification with 10 years experience as AWW as on 01.01.2020.
2. As per G.O No.4213 dated 03.03.2014 of Govt. in W & C.D Department, Odisha, Bhubaneswar that the permission is not mandatory but she has to intimate authority about appearing and passing of the examination being in service. Hence in service A.W. Workers should have taken leave to appear the H.S.C examination in distance / private / Ex-regular mode will be considered as valid. In Service Candidates appeared the HSC examination in regular mode shall be rejected.
3. Since date of joining as A.W. Worker is most important to prepare the gradation list. Sub-Collector, Malkangiri –cum-Chairperson directed all the CDPOs to submit authentic joining report as A.W. Worker and if joining report is not available then office records / documents to produce before the Committee for acceptance her joining as A.W. Worker.
4. AWWs who have submitted matriculate/HSC certificate from different board other than BSE (Odisha) are supposed to submit the certificate equivalent to the list notified under Notification No-252 dated.5.08.2014 & Resolution No-06 & 07 dated.17.05.201 of B.S.E, Odisha to taken as valid. It is decided by the committee that the AWWs passed HSC or equivalent Certificate examination from other institutions/Board, which are not enlisted in the equivalency list issued by the Govt. of Odisha (BSE, Odisha) vide letter no.252 dated 05.08.2014 will not be considered for inclusion in the valid tentative Gradation list.

As per clarification communicated by Govt. vide Letter No.11454 dated.22.07.2016 of Additional Secretary to Govt., W & CD Department, AWWs completed ten years of qualifying service and having matriculations (HSC) qualification as on 01.01.2020 are eligible to be enlisted in the common gradation of the district for consideration of selection to the rank of ICDS lady Supervisor. As per clarification communicated vide Letter No.11454 dated.22.07.2016 of Govt. in WCD & MS Department, Odisha, Bhubaneswar, A.W. Workers who have passed HSC or equivalent examination while in service and completed 10 years of service as such is eligible for empanelled in the gradation list, keeping in view of her date of joining as A.W. Worker, provided she has to acquire the required qualification as on 01.01.2020.

The HSC certificate and Caste certificates of the Anganwadi Worker in case of SC/ST/SEBC A.W. Workers, having 10 years of experience as A.W. Worker were thoroughly scrutinized by the committee before releasing the Tentative Gradation List.

The District Social Welfare Officer, Malkangiri appraised that list of 269 (Two hundred Sixty-nine) A.W Workers have received for preparation of the Gradation List from the CDPOs of this district. Basing on the eligibility criteria 143 (One Hundred Forty-three) A.W. Workers are listed in valid list and the rest 126 Nos (One Hundred Twenty-Six) A.W. Worker are placed in the Reject List.

The District Social Welfare Officer, Malkangiri has placed 100(Hundred) number of objections / revised documents received from the A.W Workers through the CDPOs concerned within the objection period i.e. 21.12.2020.

After verification and going through the records / reports submitted by the C.D.P.Os concerned pertaining to the A.W Workers, the Scrutiny committee decided to prepare the Final Gradation List after disposing the objections / documents received in the stipulated objection period observing the following criteria keeping in view to the Govt. guidelines:

1. The committee decided to allow the objections of A.W. Workers for enrollment in the Gradation List who names were placed in the Reject List of Tentative Gradation List due to doubtful date of joining, if authentic documents duly attested by the CDPO concerned are received within the objection period.
2. The cases which were not considered due to want of authentic Appointment Order of A.W.W in the Tentative Gradation List shall be considered if the documents/report is now submitted by the AWW or by the office concerned with certification shall be enlisted in the valid Gradation List if she is otherwise eligible.
3. As per letter No. 11714 / WCDMS, Dt.22.10.2020 Govt. in WCD & MS Department, Odisha, Bhubaneswar A.W. Workers engaged in below age i.e. before attaining the age of 18 years and previously placed in the reject list shall be considered as valid by enhancing their date of joining on the date of attaining 18 years.


