ORDER

Sub:- Establishment of Group – “B” employees- Appointment of Group-B (Jr.Branch) Employee by way of selection from 10 years working experience as AWWs.

In pursuance of provision contained in the Odisha Children & Women Welfare Service Rules, 1989, Amendment Rules, 2019 communicated vide Lr. No.4062 dated 03.03.2020 of Govt. in WCD & MS Department, Odisha, Bhubaneswar and Odisha Group-B Posts (Contractual Appointment) Rules, 2013 formulated by the Government of Odisha vide General Administration Department Notification No. 1147 dated 17.01.2014 and as per the recommendation of District Level Selection Committee meeting held on 23.12.2020 under the Chairmanship of Collector, Malkangiri the following Anganwadi Worker are hereby selected for the post of Lady Supervisor and posted against the vacancy of Lady Supervisor as mentioned against each on CONTRACTUAL BASIS with fixed monthly consolidated emoluments of Rs.16880/- (Rupees Sixteen thousand Eight hundred eighty) only per Month as per stipulated terms and conditions. She should report to their place of posting within 15 days from the issuance of these orders failing which the offer of appointment shall stand cancelled by the Appointing Authority.

THE APPOINTMENT IS SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS.

1. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
2. She will be under probation for a period of six years and the appointing authority reserves the right to terminate the service of the probationer if during the probation period the work and conduct of the employee is found to be unsatisfactory and to reason to believe that the employee is not suitable for the post. The period of six years shall be counted from the date of her joining in the contractual post under Rule 5.
3. During the period of contractual appointment she shall draw consolidated monthly remuneration.
4. She shall not be entitled to draw D.A., HRA, RCM and other allowances during the period of contractual appointment.

5. The provisions of OCS (CCA) Rules, 1962 and Odisha Govt. Servant Conduct Rules, 1959 shall be applicable for the contractual Supervisor.

6. She is entitled for 10% enhancement of consolidated remuneration each year on completion of one year from the date of joining on contractual basis subject to satisfactory performances.

7. On the date of satisfactory completion of six years of contractual service under sub-rule 9(10). They shall be deemed to have been regularly appointed. A formal order of regular appointment shall be issued by the appointing authority. They will be entitled for regular Pay and other benefits only after regular appointment in the post.

8. Any document proved contrary or forged on verification at any time the service of the employee concerned will be terminated without assigning any reasons thereof and prosecution will be initiated against her for submission of forged document.

9. She will be under the contributory pension scheme as per Finance Department Letter No. 48973/F dated 24.10.2005.

10. She should submit the following documents at the time of her joining before the concerned Head of the Office.


ee. Medical certificate of fitness from a Medical Officer not below the rank of a Asst. Surgeon of any Govt. Hospital.

ff. Two Character Certificate from the Gazetted Group-A or Group-B Officers.

gg. An Oath of allegiance to the constitution of India.

hh. Educational qualification certificates (In Original) in support of the age etc for verification.

ii. An undertaking in shape of an affidavit to the effect that no criminal case is pending against her and genuineness of their certificate.






