Having gone through the technical bids submitted by the bidders, it is observed that no bidders have submitted satisfactory documents for all the parameters

As such, the committee has unanimously decided not to proceed and hence cancelled the bidding process and to re-invite fresh bids through expression of interest for empanelment of training partner for undertaking placement linked training programmes for the 30 women Candidates of Malkangiri district to be published later
