Sub: Establishment of Class – III Employees – Appointment of Revenue Inspector.

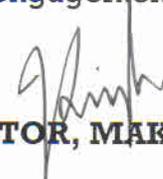
In pursuance of Letter No. IIE-126/2021/1262(C)/ OSSSC dated 10.12.2021, No. IIE-767(C)/2021/1016/OSSSC dated 27.07.2021, for Written Test Examination, No. IIE-124/2021/1099(C)/OSSSC dated- 02.11.2021 for Skill Test in Computer Application (Practical) and in response to the Advertisement No. IIE-45/2021-619(C)/OSSSC dated 22.06.2021 of Odisha Sub-Ordinate staff Selection Commission, Bhubaneswar. The under mentioned candidates who have come out successful in the aforesaid Examinations for the Recruitment year 2021 are hereby appointed as **Revenue Inspector** on Contractual basis under Rule 5 & 8 of the Odisha District Revenue Service (Method of Recruitment and condition of Services) as per Notification No. 32010/Gen dated 12.11.2013 of Govt. in General Administration Department, Odisha Bhubaneswar with a Consolidated Remuneration of **Rs. 25,300/- P.M.** as per **Notification No. – 28626 /Gen dated – 27.10.2021** and posted as such against the existing vacancy to the Offices as noted against each below:

The appointment is subject to the following conditions: -

1. The appointment is on contractual basis for a period of Six years from the actual date of joining in accordance with Rule-9 of Condition of Service meant for Contractual Employees appointment under Sub-Rule (2) of Rule-5 as per Notification No. 32010/Gen dated.12.11.2013 of Govt. in General Administration Department, Odisha Bhubaneswar.
2. The appointment can be terminable at any time without any notice or assigning any reason thereto.
3. No travelling allowance is allowed to join their place of engagement.
4. During the period of contractual appointment, they shall draw consolidated monthly remuneration at the rates prescribed in the Annexure appended in the Notification No. 19575/Gen dated 12.09.2017.
5. Subject to satisfactory performance, the consolidate remuneration shall be enhanced as per slabs prescribed appended to these Rules on completion of each year of service.
6. They shall not be entitled to DA, HRA and other allowances during the period of contractual appointment.
7. They shall be entitled to leave under the provisions of Odisha leave Rules, 1966 at par with regular employees of Govt. of Odisha.
8. They should abide by OCS Conduct Rules, 1959 subject to OCS (Classification Control & Appeal) rules, 1962.
9. They shall be enrolled under the New Pension Scheme contained in the OCS (Pension) Rules, 1992 from the date of contractual appointment under Sub-Rule (1) of Rule-8.
10. This appointment order is **valid for a period of 07 (Seven) days** from the date of issue of this order and in case, no intimation of the candidate having joined the office to which posted is received by 23/12/2021, the order of appointment shall be treated as cancelled.
11. The candidate shall produce/furnish the following documents at the time of joining before the Head of Office for acceptance of his/her joining report.
 - (i) Medical Certificate as required under Rule-49 read with Rule-50 of Orissa Service Code.
 - (ii) Two Character Certificates from two different Gazetted Officers not being related to the candidate.
 - (iii) Declaration to the effect that the candidate has not more than one spouse living.

- (iv) Original Certificates in support of his/her higher qualification & date of birth/Caste/Tribe obtained from competent authority for verification and return.
- (v) Oath of allegiance to the constitution of India.
12. Refusal to accept the engagement will be treated as cancelled and the candidate shall be deemed to have forfeited his/her claims for future engagement as Revenue Inspector in this department.
13. If the candidate is employed in any other organisation, he/she should submit the copy of his/her relieve order from the post which he is continuing at the time of his /her joining in the new engagement.

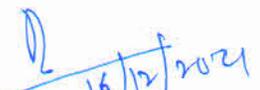

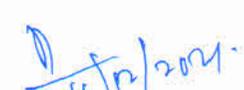
