

3. Terms and Conditions

- All interested bidders are requested to attend the auction on scheduled date and time.
- Every intending bidder will have to deposit **Rs. 15,000/-** (Rupees fifteen thousand) only in advance as Cash/ Banker Cheque/Bank Draft in favour of Commandant, 160 Bn BSF payable at SBI Malkangiri as earnest money at least one hour before the scheduled time of auction, which will be adjusted/refunded after finalization of auction on the same day.
- All bidders must be in possession of their Aadhar Card, PAN Card and Income Tax clearance certificate in original and copy of GST registration certificate which will be scrutinized by the auction board, failing which bidder will not be allowed to participate in the auction.
- The stores will be sold on "as is where basis is". The auction process will be conducted by auction committee of this Office. Taxes and duties (GST) that may be levied by Govt. of India will be extra as applicable.
- The bidders will be allowed to inspect the said stores.
- Other terms and conditions will be announced by the board of Officers appointed for the purpose before commencement of the auction.
- The successful bidders shall have to deposit 25% value of the auctioned store plus admissible taxes/surcharge immediately in the shape of Cash/Bank draft after the auction is over.
