
**CORRIGENDUM TO ADVERTISEMENT NO. 2877/SSD DATED
31.12.2021 FOR ENGAGEMENT OF INITIAL APPOINTEE TEACHERS**

Pursuant to this office advertisement No. 2877/SSD dated 31.12.2021 published in the Odia daily The SAMAJ & The PRAMEYA on 02.01.2022, applications were invited for engagement of Initial Appointee Teachers and the last date of receipt of the application was 22.01.2022. Further, it was mentioned at Para 2. of the said advertisement that, the age limit for applying for the post was below 32 years and above 21 years as on 30.11 2021.

In the meanwhile, the General Administration & Public Grievance Department, Odisha, Bhubaneswar has amended the Odisha Civil Service (Fixation of Upper Age Limit) Rules, 1989 vide their Notification No. 777/GAD dated 11.01.2022 (copy enclosed) and clarification issued by ST & SC development Department, Odisha, vide their letter No. 944/SSD dated 20.01.2022 wherein **the upper age limit for applying for any post shall be 38 years for the advertisement made during the year 2021, 2022 & 2023.**

Hence, in partial modification to the said advertisement with respect to fixation of upper age limit is allowed as per the GA&PG Department, Odisha Notification No.771/GAD dated 11.01.2022. The Upper Age Limit as per provision of Rule-2 of OCS (Fixation of Upper Age Limit) Amendment Rules, 2022 shall be applicable to all appropriate and eligible candidates. All other terms and conditions of the original advertisement will remain un-altered.

Accordingly applications complete in all respect superscribed as **“Application for engagement of Initial Appointee through written Examination under SSD Department Schools of Malkangiri District”** are invited from such eligible candidates (the candidates who are in-eligible earlier due to upper age criteria of original advertisement and now eligible as per the age relaxation of the GA & PG Department, Odisha Notification No.771/GAD dated 11.01.2022) in the prescribed format so as to reach to the District Welfare officer, Malkangiri, Collectorate, Malkangiri by Registered Post/ Speed Post only by **30.04.2022 by 5:00PM**. No application other than the applications of such permissible over aged candidates will be entertained. The over aged candidates who have already applied and their applications were received within due date need not have to apply again.




