**Bid Security:**

The bidder shall furnish bid security of **Rs.30,000/-** (Thirty thousand) only in the shape of STDR Pledged in favour of the District Fisheries Officer, Malkangiri along with the tender as security deposit. After completion of the tender process, the amount to be refunded to the unsuccessful bidders.

The bid security of successful bidder will be refunded after supply of the required quantity to District Fisheries Officer, Malkangiri, as per the specification with the terms and conditions. The vehicle should be supplied within **10 days** of receipt of order. If the bidder fails to supply the vehicle within the scheduled time, the Security Deposit shall be forfeited.






