

#### **Brief Scope of Work**

BDO Kalimela would like to setup Chicken Hatching and brooding Unit at Kalimela likely to be run by local SHGs for revenue generation and to support local feedstock. It is expected that it will impart good practice at village level and simultaneously generation of revenue. The project would be funded under Special Central Assistance by the Govt. of India.

In this regard, BDO Kalimela is looking for a partner who is ready to work with us as per terms & conditions defined in such tenders. The brief scope of work involves:

- I. The Projects are to be implemented on a turnkey basis. The successful bidder's are responsible for supply, installation and commissioning including maintenance of all components under scope of supply for the desired guarantee period.
- II. The successful bidder will be maintaining and up keeping the supplied infrastructure at each location during the project period of 1 year.
- III. To impart Training of 10 days to the local SHGs regarding its operation and maintenance.
- IV. The scope of supply item wise is detailed in Section 3.

#### **2. Pre-Qualification Criteria**

The bidder should meet the following pre-qualification criteria:

- I. The bidder must be a registered company in India, registered under the Companies Act 1956 and should be in existence since last 3 years or more. Consortium in any form is not allowed.
- II. The eligibility of the Bidder will be judged based on own or the OEMs credentials. Hence, in case of bidder is channel Partner, the respective OEM has to authorize in writing on its letter head to allow the Partner in using its credentials for eligibility.
- III. OEMs / Channel partners of OEM's can participate in this tender. For execution of orders, OEM may declare in the Manufacturer's Authorization Form) its channel partners who will be treated as supplier.

- IV. The OEMs / Channel partner's of OEM's should have presence in Odisha for last 3 (three) financial years in the same business area. Documentary evidence with self-attested is to be attached with the bid.
- V. The Bidder should have not been banned / black listed as on date by any Government Agencies / Govt. Department/ Quasi Govt Department / PSU / Board/ council or similar organization on grounds of non-performance, fraud practice, financial irregularities. A self declaration on the letterhead of the bidder duly signed and stamped by the Authorised Signatory to be submitted.
- VI. Bidders must submit tender specific authorization from the OEM of each of the hardware items including the computing device, isolation transformer and UPS. Bids without such authorizations are liable to be summarily rejected.
- VII. All hardware items must be quoted with minimum 1 year on site comprehensive manufacturer's replacement warranty. All the Bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation and comprehensive maintenance of services during replacement warranty period.
- VIII. Tender document must be submitted along with all the relevant documents. This is required to show that the bidder had accepted all the terms and conditions mentioned in this tender document.
- IX. However, Block Authority reserves the right to evaluate the Bidder's performance through the report from any Govt. Department / Quasi Govt. Dept / PSU / Board Council or similar organization at their own discretion or ask the bidder to produce service satisfaction certificate from the customer base mentioned as per above criteria.
- X. Tender Specific Authorization Certificate for the supply, installation and maintenance during replacement warranty period from the OEM.
- XI. Technical Brochures of items quoted. Printed and published Brochure and / or Web site reference essential.
- XII. The bidder should have valid documentary proof of GST registration
- XIII. PAN registration number- Self-Certified Copy of PAN /GST registration
- XIV. The successful bidder has to obtain no objection certificate (NOC) from the appropriate authority before installation at Kalimela.
- XV. The bidder should submit (self-attested) documentary proof in support of each of the above conditions. The incomplete offers will be summarily rejected without any further correspondence.
- XVI. Bidders who will qualify basis the above criteria may be called for a technical presentation in order to evaluate the technical understanding and capability of the bidders. Tendering authority has all the rights to reject or select the bidders for further evaluation.
- XVII. **Sale of Tender papers:-** Bid documents consisting, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the Govt. website [www.malkangiri.nic.in](http://www.malkangiri.nic.in) from **09.11.2022 to 23.11.2022** . No tender paper will be sold by the Panchayat Samiti, Kalimela or any other offices. - XVIII. The bidders has to submit bid having tender paper cost of requisite amount in shape of Demand draft/ Banker's cheque in favour of BDO, Kalimela from any nationalized/ scheduled Bank of India payable at SBI Kalimela.
- XIX. Tendering authority reserves the right to accept or reject any or all the offers without assigning any reason.
- XX. The offers are to be submitted to: BDO, Kalimela of Malkangiri district as per the terms and conditions as laid down in the tender specification.

**SECTION - 2**  
**TERMS AND CONDITIONS**

**1) Price Basis**

- a) Prices shall be quoted in Indian rupees, and shall be inclusive of all applicable taxes. The taxes will be shown separately. TDS deduction shall be made as per the prevailing Govt. Laws/ notification
- b) Bidders are requested to quote the price for complete BOM, as per section-3.

**2) Validity Period of Tender**

Price quoted shall remain valid for a period of **90 (Ninety) days** from the scheduled date of Bid submission.

**3) Insurance**

The equipment supplied vide this this Tender shall be fully insured against loss or damage incidental to manufacturer or acquisition during transportation, storage, delivery and installation and handover to the tendering authority

**4) Payment Terms :** No Advance payment shall be made in any case. However part payment will be done after deployment of man & machine at the site. Final Bill shall be paid after successful commissioning of Crematorium in all respect as per scope of supply and certification of the Engineer-in-Charge.

**5) Delivery Schedule**

The complete setup shall need to be installed and commissioned at site within **90 (Ninety) days** from the date of written order for commencement of work/supply.

**6) Penalty**

In case of delay in project implementation, the penalty would be applied by the tendering authority.

**7) Warranty**

The period of warranty on all supplied equipment's shall be minimum 1 year or the guarantee period as decided by the manufacturer. Any repair/replacement if required during the guarantee period shall be rectified by the supplier at his own cost and without any financial liability to this office.

**8) Submission of bids**

The bids have to be submitted in physical form at BDO Kalimela with technical cum Pre-qualification bid in one envelop and Financial bid in another envelop. Both the envelop should be kept in one envelop with the name of bidder & name of the work super scribed on it.

**9) Evaluation of Bids**

- a) Tendering authority shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise. Tendering authority shall carry out detailed evaluation of the substantially responsive bids. Tendering authority shall check the bid to determine whether they are complete, whether any computational errors have been made or required sureties have been furnished.
- b) Arithmetical error shall be rectified on the following basis
  - I. If there is a discrepancy between the unit price and total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Purchaser.
  - II. In case of discrepancy between words and figures, the amount in words shall prevail
- c) A bid determined as substantially non-responsive shall be rejected by the purchaser.
- d) TENDERING AUTHORITY may waive any minor infirmity or nonconformity or irregularity in the bid which does not constitute a material/service deviation.
- e) TENDERING AUTHORITY shall evaluate in detail and compare the bids which are substantially responsive

f) Total Cost of Hardware, Software fixing and Services inclusive of all taxes (As asked as point C in Financial bid format) will be considered for the evaluation of L1 bidder

**10) GST Registration:**

The bidder must have valid GST Registration during submission of Bid.

**11) Termination of Default**

BLOCK TENDER COMMITTEE may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the contractor, terminate this contract in whole or in part.

- a. if the contractor fails to deliver any or all the services/goods within the time period specified in the contract, or any extension thereof granted by BLOCK TENDER COMMITTEE
- b. if the contractor fails to perform any other obligation(s) under the contract; and
- c. if the contractor, in either of the above circumstances, does not remedy his failure within a period of 15 days (or such longer period as the purchaser may authorize in writing) after receipt of the default notice from BLOCK TENDER COMMITTEE.
- d. In the event BLOCK TENDER COMMITTEE terminates the contract in whole or in part pursuant to above clause, BLOCK TENDER COMMITTEE may procure, upon such terms and in such manner as it deems appropriate, goods/services similar to those undelivered and the contractor shall be liable to BLOCK TENDER COMMITTEE for any excess cost for such similar goods/services. However, the contractor shall continue the performance of the contract to the extent not terminated.

**12) Blacklisting. The firm shall be black-listed, if it is found that:-**

- i) Forged documents are submitted OR
- ii) If it becomes responsive on the basis of submission of bogus certificate/information. OR
- iii) In case of non-supply of materials or supply of substandard quality or supply of materials found to have been previously used or having reconditioned parts.

**13)** Bidder shall not have been debarred/black listed by The central Govt./state Govt./ Public sector undertaking/any other Local body. If in future, it comes/brought to the notice of The BLOCK TENDER COMMITTEE, during the tenure of this contract, that any disciplinary/penal action is taken against the bidder due to violation of terms and conditions of the tender allotted to Bidder. The bidders / manufactures which amounts to cheating/depicting of amplified intention anywhere in The BLOCK TENDER COMMITTEE, KALIMELA or either by any of central Govt./state Govt./Public sector undertaking/any other Local body, The BLOCK TENDER COMMITTEE, KALIMELA will be at discretion to take appropriate action as it finds fit.

**14)** All the above conditions should be strictly adhered to failing which the tender will be treated as non-responsive and no correspondence will be entertained in the matter.'
