The said quotations were opened by the District Tender Committee Members in presence of bidders like Ch. Nageswar Pattnaik, M/s Shiva Computech, Malkangiri. After scrutiny of the documents it is found that 3 Nos. firms 1. M/s Bhagawati Electronic Process, 2. Mahamaya Printing Press 3. Maa Tarini Communication have not qualified in technical Bid due to non-submission of relevant documents.

Accordingly a comparative statement remain 5 agencies such as Blue Ink Enterprises B/L-105, ASS Nagar, Bhubaneswar-751010, Deepak Press Stones Road, Cuttack-753002, M/s Shiva Computech, At-Malikeswar Colony, Malkangiri-764045. Bhairaba Creation Infront of BSNL Office, Main Road, Malkangiri- 764045 and OMM Arts, Tulasi Nagar, Balangir, 767001.

After scrutiny of the comparative statement, the committee found that Deepak Press Stones Road, Cuttack has quoted the lowest rate @ 0.51 paisa where Blue Ink Enterprises @ 0.70 Paisa per page, M/s Shiva Computech @.0.89 Paisa per page, Bhairaba Creation @.0.75 Paisa per page and OMM Art Tulasi Nagar @.Rs.1.45 paisa per page. for printing of Form-6B under Special Summary Revision of Photo Electoral Roll, 2023.

Hence the committee unanimously decided to select Deepak Press Stones Road, Cuttack as the L-1 Bidder for printing of Form-6B as it has quoted lowest rate.

The meeting was ended with vote of thanks to the chair and the members.
