Whereas, Smt Nilima Jena, defaulting Junior Teachers (Contractual) has submitted her show cause reply within the stipulated period.

Whereas, the explanation dated.15.11.2022 of Smt Nilima Jena, Junior Teacher (Contractual) of MV-03 NUPS, Malkangiri Block, is not satisfactory for such prolonged absence from duty, thereby the charges of Un-authorised absent, dereliction to duty, Violation of Terms and Condition of contractual engagement & misconduct is established.

Whereas, due opportunity was given to the above Junior Teacher (Contractual) to show cause as to why they shall not be disengaged from the post for such lapses vide notice No. 5011/Estt/22 dated.09.11.2022.

Under above facts and Circumstances, I Shri Vishal Singh, IAS, Collector-cum-Chief Executive Officer, ZP, Malkangiri do hereby disengage Smt Nilima Jena, from the post of Junior Teacher (Contractuals) with immediate effect from the last day of her duty for unauthorized absence, dereliction of legitimate duty, Misconduct, violation of terms and condition of contractual engagement and in the educational interest of the Children of the tribal area.
