Instead of rectification to her candidature and placing her at selected merit list, another Pinki Sarkar of same address, Seriel No. 1159 (deserves to be rejected) has been mistakenly placed at selected merit list. It is observed that Anna kumar Dhali, placed at Application no. 325 has secured 61.33% of marks in +2. He belongs to SC category with PWD in Locomotor disability category. Secondly, it is observed that, Rajkishor Pradhan placed at Application No. 446, has secured 56.44 % marks in +2 belongs to SEBC category with PWD in Deaf and hard of hearing category. As per guideline of PR&DW Deptt. Vide Letter No. PT3-PR-NREG-EST7-0017-2019, 22704 Dtd-05.12.2019, the category of Deaf & hard of hearing PWD gets the 1st priority in recruitment over locomotor disability, which is the 2nd priority. Accordingly, to prioritise the PWD of Deaf & hard of hearing, the selection of Rajkishor Pradhan, comes as per guidelines. So the claim of Anna Kumar Dhali has no merit and hence not considered.	Both the applications of Pinki Sarkar were observed. (1) One Pinki Sarkar, D/O Late Subash Chandra Sarkar, At. Reclamation Colony, Malkangiri, having Application No. 1159 was scrutinized. It was found that Pinki Sarkar was placed at Reject List, published on date. 28.07.2022, because she had completed her PGDCA before +2. Objection was invited, but she did not file any objection during the objection period. (2) Another Pinki Sarkar, D/O of Surya Kanta Sarkar, At.
