


1. The age of candidate must be between 21 to 35 years as on 01.01.2017 with relaxation as admissible in favour of SC/ST/OBC/PwDs/Ex-Serviceman etc.
2. In case of more than one candidate has equal weight-age of marks, the candidate with more experience in relevant field will be given preference. The decision of the selection committee in this regard shall be final.

The District Level Selection Committee unanimously decided to select the candidates for the post of OH & SH Malkangiri, who have secured the highest career marks and issue the engagement order with necessary fixed terms and conditions. Before finalization of the panel list, the career marks of all candidates will be upload in Dist. Website www.malkangiri.nic.in and give 10 days time to receive objections if any from the candidates. The authentic & evidence based objection of the candidates will be accepted & accordingly modify the career weightage. The objections will be received through speed post/registered post only on or before 20th Feb. 2023. The DLSC is not responsible for postal delay. The next DLSC meeting will be called under the chairmanship of the ADM, Malkangiri on 21st Feb. 2023 (4.30 PM) to finalize the panel merit list of the candidates for all the posts of OH & SH, Malkangiri and the proceeding will be submitted before the Collector & DM, Malkangiri for approval. The meeting concluded with a vote of thanks to the chairperson and all the members of the DLSC.
