

Proceeding of the Dist. Selection Committee held on 21st Feb.2023 Observation Home and Special home, Malkangiri.

The meeting of the District Level Selection Committee (DLSC) was held on 21st. Feb.2023 under the chairmanship of the ADM Malkangiri on behalf of the Collector & DM, Malkangiri. The selection committee was convened to finalize the list of eligible candidates for the posts of Superintendent, Child Welfare Officer, Counsellor, Pharmacist, Home Father, Cook, Night Watchman, PET Instructor, Music and Art and Craft Teacher, Educator, House Keeper for Observation Home and Special Home, Malkangiri.

The DCPO Malkangiri, member convener of the DLSC briefed the criteria of the selection procedure and the process of selection of the candidates. The DCPO informed the committee that, as per the reference letter no : 246(A)/OSCPs/OH&SH-CPC/0199/2021, Dated 13/01/2022 and Resolution No.10102/WCD-CW-MISC-0023/2020, Dt.15/09/2020 issued by the Women & Child Development Dept, Govt. of Odisha, the following selection criteria have been followed to prepare the Merit List of the candidates applied for different post of OH & SH Malkangiri.

1. The age of candidate must be 21 to 45 years as on 01.01.2022 with relaxation as admissible.
2. In case more than one candidate has equal weight-age of marks, the candidate with more experience in relevant field will be given preference. The decision of the selection committee in this regard shall be final.

The 1st District Level Selection Committee meeting held on 8th Feb. 2023, it had been unanimously decided that the draft merit list of the candidates for different posts of OH & SH Malkangiri will be published in Dist. Website www.malkangiri.nic.in and after hearing of objections of the candidates, the final merit list will be prepared. Accordingly, the draft merit list of all candidates was uploaded in Dist. Website on 10th Feb. 2023 inviting objection on or before the 20th Feb. 2023 if any from the candidates through the registered post/ speed post only. Within the stipulated time, as many as 14 objections had been received. After due hearing and disposal of such objection by the DLSC basing on the authentic evidence, the final lists and a Panel of Merit list @ 01:05 for each post of OH & SH, Malkangiri have been prepared.



Before issue the contractual engagement order to the eligible candidates, all the candidates in merit list will be called for document verification and counselling. After documents verification and counselling, the engagement order with the terms and conditions as fixed for the posts of Observation Home & Special Home, Malkangiri will be issued. For the document verification, a suitable date tentatively 6th March 2023 has been fixed. The DLSC be verify the documents and submit the report before the Chairman cum Collector & DM, Malkangiri for approval and to issue the appoinmen orders. The meeting concluded with a vote of thanks to the chairman and all the members of the committee.
