



Sealed tenders in conformity with detailed tender call notice with admissible terms & conditions are invited from Original equipment manufacturers/ Authorized dealers/ reputed firms/companies/agencies which will be received up to 5.00 P.M on 18.03.2023 for supply of furniture and other items as stipulated in the Tender Notice and will be opened on 20.03.2023 at 11.00 A.M in presence of the tenderers or their authorized representatives under the chairmanship of Block Development Officer, Korukonda.

#### **Brief Scope of Supply**

BDO Korukonda would like to provide advanced infrastructure and amenities in the smart classes and High Schools being transformed under 5T initiative under Govt. of Odisha. This will impart smart education and ease of understanding of the students leading to strengthening learning ability. The expenditure towards said infrastructure shall be funded under the scheme "Mo School-5T High School Transformation initiative", Govt. of Odisha.

In this regard, BDO Korukonda is looking for a partner who is ready to work with us as per terms & conditions defined in such tenders. The brief scope of supply involves:

- I. The Projects are to be implemented on item-rate contract basis as per provisions stipulated in various clauses of OPWD. The successful bidders will be responsible for supply, installation and commissioning under scope of supply including maintenance of all components for the desired guarantee period.
- II. The successful bidder will be maintaining and up keeping the supplied infrastructure at each location for a minimum project period of 01 (one) year.
- III. To impart Training to teachers at targeted schools for operation and maintenance of Interactive panels.
- IV. The scope of supply item wise is detailed in Section 3.

#### **2. Pre-Qualification Criteria**

The bidder should meet the following pre-qualification criteria:

- I. The bidder must be a registered company in India, registered under the Companies Act 1956 and should be in existence since last 3 years or more. Consortium in any form is not allowed.
- II. The eligibility of the Bidder will be judged based on own or the OEMs credentials. Hence, in case of bidder is channel Partner, the respective OEM has to authorize in writing on its letter head to allow the Partner in using its credentials for eligibility.
- III. OEMs / Channel partners of OEM's can participate in this tender. For execution of orders, OEM may declare in the Manufacturer's Authorization Form) its channel partners who will be treated as supplier.

- IV. The OEMs / Channel partner's of OEM's should have presence in Odisha for last 3 (three) Financial Years in the same business area. Documentary evidence with self-attestation is to be attached with the Bid documents.
- V. The Bidder should have not been banned / black listed as on date of BID opening by any Government Establishment / Govt. Department/ Quasi Govt Department / PSU / Board/ Council or similar Organization on grounds of non-performance, fraud practice, financial irregularities. A self declaration on the letterhead of the bidder duly signed and stamped by the Authorised Signatory required to be submitted.
- VI. Bidders must submit tender specific authorization from the OEM of each of the hardware items including the Computing Device, Isolation Transformer and UPS. Bids without such authorizations are liable to be summarily rejected.
- VII. All Hardware items must be quoted with minimum 03 (Three) year on site comprehensive manufacturer's replacement warranty. All the Bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation and comprehensive maintenance of services during replacement warranty period.
- VIII. Signed copy of Tender document must be submitted along with all the relevant documents. This is required to show that the bidder has accepted all the Terms and Conditions mentioned in this Tender Document.
- IX. However, Block Authority reserves the right to evaluate the Bidder's performance through the report from any Govt. Establishment/Department / Quasi Govt. Dept / PSU / Board/ Council or similar Organization at their own discretion or will ask the bidder to produce Service Satisfaction Certificate from the Customer base mentioned as per above criteria.
- X. Tender Specific Authorization Certificate for supply, installation and maintenance during replacement warranty period from the OEM.
- XI. Technical Brochures of items quoted. Printed and published Brochure and / or Web site reference is essential.
- XII. The bidder should submit self-attested copy of valid GST registration & IT PAN registration.
- XIII. The bidder should submit (self-attested) documentary proof in support of each of the above conditions. The incomplete offers will be summarily rejected without any further correspondence.
- XIV. The Bidders who will qualify on the basis of fulfilling above criteria may further be called for a technical presentation in order to evaluate the technical understanding and capability of the bidders. Tendering authority has all rights to reject or select the bidders for further evaluation.
- XV. **Sale of Tender papers:-** Bid documents consisting, the schedule of quantities and the set of Terms and Conditions of contract and other necessary documents can be accessed in the Govt. website [www.malkangiri.nic.in](http://www.malkangiri.nic.in) from **09.03.2023 to 18.03.2023** . - XVI. The bidders have to submit bid having tender paper cost of requisite amount in shape of Demand Draft/ Banker's cheque in favour of BDO, Korukonda from any Nationalized/ Scheduled Banks of India payable at HDFC, MALKANGIRI.
- XVII. Tendering authority reserves the right to accept or reject any or all the offers without assigning any reason there of.
- XVIII. The Bid Application required to be submitted to the BDO, Korukonda, Malkangiri District as per the Terms and Conditions as laid down in the tender specification.



**SECTION - 2**  
**TERMS AND CONDITIONS**

**1) Price Basis**

- a) Prices shall be quoted in Indian rupees, and shall be inclusive of all applicable taxes. The taxes will be shown separately. TDS deduction shall be made as per the prevailing Govt. Laws/ Notifications.
- b) Bidders are requested to quote the price for complete BOM, as per section-3.

**2) Validity Period of Tender**

Price quoted shall remain valid for a period of **90 (Ninety) days** from the scheduled date of Bid submission.

**3) Insurance**

The equipment supplied vide this this Tender shall be fully insured against loss or damage incidental to manufacturer or acquisition during transportation, storage, delivery and installation and handover to the tendering authority

**4) Payment Terms :** No Advance payment shall be made in any case. Final Bill shall be paid after successful commissioning of Interactive Flat Panel in all respect as per scope of supply and certification of the Engineer-in-Charge.

**5) Delivery Schedule**

The complete setup shall need to be installed and commissioned at site within **15 (Fifteen) days** from the date of written order for commencement of work/supply.

**6) Penalty**

In case of delay in supply/commissioning/installation of IFP Display Board, the penalty would be imposed by the Tendering Authority as per codal provisions of OPWD.

**7) Warranty**

The period of warranty on all supplied equipment's shall be minimum 03(Three) years. Any repair/replacement, if required during the Warranty Period shall be provided by the supplier at his own cost and without any financial liability to this office.

**8) Submission of Bids**

The Bids have to be submitted in physical form to BDO Korukonda with Technical cum Pre-qualification Bid in one envelope and Financial Bid in another envelope. Both the envelopes should be kept in another Bigger size envelope with the name of the bidder & the Name of the work should be super scribed on it.

**9) Evaluation of Bids**

- a) Tendering authority shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise. Tendering Authority shall carry out detailed evaluation of the substantially responsive bids. Tendering Authority shall check the bid to determine whether they are complete, whether any computational errors have been made and required any sureties have been furnished.
- b) Any Arithmetical error shall be allowed for rectification on following basis
  - I. If there is a discrepancy between the Unit price and Total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be allowed for correction by the Purchaser.
  - II. In case of discrepancy between words and figures, the amount in words shall prevail upon.
- c) A bid determined as substantially non-responsive shall be rejected by the Tendering Authority.



d) TENDERING AUTHORITY may waive any minor infirmity or nonconformity or irregularity in the bid which does not constitute a material/service deviation.

e) TENDERING AUTHORITY shall evaluate in detail and compare the bids which are substantially responsive.

f) Total Cost of Hardware, Software fixing and Services inclusive of all taxes (As asked at point C in Financial Bid format) will be considered for the evaluation of L1 bidder

**10) GST Registration:**

The bidder must have valid GST Registration during submission of Bid.

**11) Termination of Default**

BLOCK TENDER COMMITTEE may, without any prejudice to any other remedy for breach of contract, by written notice of default, sent to the contractor, terminate this Bid in whole or in part.

- a. if the Bidder/Supplier fails to deliver any or all the services/goods within the time period specified in the supply order, or any extension thereof granted further by BLOCK TENDER COMMITTEE
- b. if the Bidder fails to perform any other obligation(s) under the contract and
- c. if the Bidder, in either of the above circumstances, does not take remedial measure to comply his failure within a period of 15 days (or such longer period as the Bid Authority may authorize in writing) after receipt of the Default Notice from BLOCK TENDER COMMITTEE.
- d. In the event BLOCK TENDER COMMITTEE terminates the contract in whole or in part pursuant to above clause, BLOCK TENDER COMMITTEE may procure, upon such Terms and in such manner as it deems appropriate, Goods/Services similar to those undelivered and the Bidder shall be liable to BLOCK TENDER COMMITTEE for any excess cost for such similar Goods/Services. However, the Bidder shall continue the performance of the Bid to the extent not terminated.

**12) Blacklisting. The firm shall be black-listed, if it is found that:-**

- i) Forged documents are submitted OR
- ii) If it becomes responsive on the basis of submission of bogus/and false certificate/information. OR
- iii) In case of non-supply of materials or supply of substandard quality or supply of materials found to have been previously used or having reconditioned parts.

13) Bidder shall not have been debarred/black listed by The Central Govt./state Govt./ Public Sector Undertaking/any other Local body. If in future, it is known/brought to the notice of The BLOCK TENDER COMMITTEE, during the tenure of this contract, that any disciplinary/penal action is taken against the bidder due to violation of Terms and Conditions of the tender allotted to Bidder. The Bidders / Manufactures which are amount to cheating/depicting of amplified intention anywhere in The BLOCK TENDER COMMITTEE, KORUKONDA or either by any of Central Govt./State Govt./Public Sector Undertaking/any other Local body, The BLOCK TENDER COMMITTEE, KORUKONDA will be at discretion to take appropriate action as it deems fit.

14) All the above conditions should be strictly adhered to failing which the tender will be treated as non-responsive and no correspondence will be entertained in the matter.
