



SECTION - I (REQUEST FOR PROPOSAL)

Sealed tenders in conformity with detailed tender call notice with admissible terms & conditions are invited from Original equipment manufacturers/ Authorized dealers/ reputed firms/companies/agencies which will be received up to **5.00 P.M on 24.03.2023** for supply of amenities for advanced education of students & other items as stipulated in the Tender Notice which will be opened on **27.03.2023 at 11.00 A.M** in presence of the tenderers or their authorized representatives under the chairmanship of Block Development Officer, Korukonda.

Brief Scope of Supply

BDO Korukonda would like to provide advanced infrastructure in the field of IT and Computer science as e-Library in various High schools run under Govt. of Odisha. This will impart smart education and ease of understanding of the poor students thereby strengthening learning ability. The expenditure towards said infrastructure shall be funded under the scheme "Mo School-5T High School Transformation" Govt. of Odisha.

In this regard, BDO Korukonda is looking for a partner who is ready to work with us as per terms & conditions defined in such tenders. The brief scope of supply involves:

- I. The Projects are to be implemented on item-rate contract basis as per provisions stipulated in various clauses of OPWD. The successful bidders will be responsible for supply & installation of computers under scope of supply including maintenance of all components for the desired guarantee period.
- II. The successful bidder will be maintaining and up keeping the supplied infrastructure at each location for a minimum project period of 03 (three) years.
- III. To impart Training to teachers & students at target schools for operation and maintenance of Desktop computers in two no. of rounds.
- IV. The scope of supply is detailed in Section 3.

2. Pre-Qualification Criteria/ Essential Bid Documents Required:

The bidder should submit Bid documents in support of following pre-qualification criteria failing which the Bid shall be liable for rejection by the Tender committee:

- I. **Tender paper cost:** The tender fee in shape of Demand draft/ Banker's cheque in favour of BDO, Korukonda from any nationalized/ scheduled Bank of India payable at HDFC, Malkangiri are required.
- II. **Company Registration certificate:** The bidder must be a registered company in India, registered under the Companies Act 1956 and should be in existence since last 3 years or more. Consortium in any form is not allowed. Continuance proof is required.
- III. **OEM Authorization:** The eligibility of the Bidder will be judged based on own or the OEMs credentials. Hence, in case of bidder is channel Partner, the respective OEM has to authorize in writing on its letter head to allow the Partner in using its credentials for eligibility.



- IV. **Proof of experience in Odisha:** The OEMs / Channel partner's of OEM's should have presence in Odisha for last 3 (three) financial years in the same business area. Documentary evidence with self-attested is to be attached with the bid.
- V. **Self-declaration:** The Bidder should have not been banned / black listed as on date by any Government Agencies / Govt. Department/ Quasi Govt Department / PSU / Board/ council or similar organization on grounds of non-performance, fraud practice, financial irregularities. A self declaration on the letterhead of the bidder duly signed and stamped by the Authorised Signatory to be submitted.
- VI. **Tender specific Authorization:** The OEM of each of the hardware items including the computing device, keyboard and optical mouse with name, address and e-mail ID of the inc. signatory. Bids without such authorizations are liable to be summarily rejected.
- VII. **Replacement certificate from OEM:** All hardware items must be quoted with minimum 03 (three) years on site comprehensive warranty or warranty as offered by the manufacturer whichever is later. All the Bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation and comprehensive maintenance of services during replacement warranty period.
- VIII. **Brochure:** The Technical Brochure of items quoted. Printed and published Brochure and / or Web site reference essential.
- IX. **GST & IT PAN Regn:** The bidder should submit self-attested copy of valid GST registration & IT PAN registration. The GST shall be registered in the name of Bidder. The IT PAN registered in the name of Proprietor are also admissible.
- X. **ISO Certification:** The Bidder shall submit ISO 9001, 14001, ISO 27001 & ISO 20001 for OEM certificate.
- XI. **Signed copy of Tender document:** The Bidders must be submitted along with all the relevant documents. This is required to show that the bidder had accepted all the terms and conditions mentioned in this tender document.
- XII. Bidders who will qualify basing on the above criteria may be called for a technical presentation in order to evaluate the technical understanding and capability of the bidders. Tendering authority has all the rights to reject or select the bidders for further evaluation.
3. **Sale of Tender papers:-** Bid documents consisting, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the Govt. website www.malkangiri.nic.in from **18.03.2023 to 24.03.2023** . 4. Tendering authority reserves the right to accept or reject any or all the offers without assigning any reason.
5. The offers are to be submitted to: BDO, Korukonda of Malkangiri District as per the terms and conditions as laid down in the tender specification.



SECTION - 2
TERMS AND CONDITIONS

1) Price Basis

- a) Prices shall be quoted in Indian rupees, and shall be inclusive of all applicable taxes. The taxes will be shown separately. TDS deduction shall be made as per the prevailing Govt. Laws/ notification.
- b) Bidders are requested to quote the price for complete BOM, as per section-3.

2) Validity Period of Tender

Price quoted shall remain valid for a period of **90 (Ninety) days** from the scheduled date of Bid submission.

3) Payment Terms : No Advance payment shall be made in any case. Final Bill shall be paid only after successful supply and installation of all items as per scope of supply order in all respect and certification of the Engineer-in-Charge.

4) Delivery Schedule

The complete setup shall need to be installed at site within the stipulated delivery period as mentioned in the tender notice from the date of written order for commencement of work/supply.

5) Penalty

In case of delay in project implementation, the penalty would be applied by the tendering authority as per codal provisions of OPWD.

6) Warranty

The period of warranty on all supplied equipment's shall be minimum 03(three) years or the warranty period as provided by the manufacturer whichever is maximum. Any repair/replacement if required during the warrantee period shall be rectified by the supplier at his own cost and without any financial liability to this office.

7) Submission of bids

The bids have to be submitted in physical form having complete techno-commercial offer along with Bid documents mentioned at Cl. No. 2 of Section-1 as per DTCN through proper channel to the BDO, Korukonda kept in one envelop with the name of bidder & name of the work super scribed on it.

8) Evaluation of Bids

- a) Tendering authority shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise. Tendering authority shall carry out detailed evaluation of the substantially responsive bids. Tendering authority shall check the bid to determine whether they are complete, whether any computational errors have been made or required sureties have been furnished.
- b) Arithmetical error shall be rectified on the following basis
 - I. If there is a discrepancy between the unit price and total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Purchaser.
 - II. In case of discrepancy between words and figures, the amount in words shall prevail
- c) A bid determined as substantially non-responsive shall be rejected by the purchaser.
- d) TENDERING AUTHORITY may waive any minor infirmity or nonconformity or irregularity in the bid which does not constitute a material/service deviation.
- e) TENDERING AUTHORITY shall evaluate in detail and compare the bids which are substantially responsive
- f) Total Cost of Hardware, Software fixing and Services inclusive of all taxes (As asked as point C in Financial bid format) will be considered for the evaluation of L1 bidder

9) GST Registration:

The bidder must have valid GST Registration during submission of Bid.



10) Termination of Default

BLOCK TENDER COMMITTEE may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the contractor, terminate this contract in whole or in part.

- a. if the firm/ supplier fails to deliver any or all the services/goods within the time period specified in the contract, or any extension thereof granted by BLOCK TENDER COMMITTEE
- b. if the firm/supplier fails to perform any other obligation(s) under the contract; and
- c. if the firm/ supplier, in either of the above circumstances, does not remedy his failure within a period of 15 days (or such longer period as the purchaser may authorize in writing) after receipt of the default notice from BLOCK TENDER COMMITTEE.
- d. In the event BLOCK TENDER COMMITTEE terminates the contract in whole or in part pursuant to above clause, BLOCK TENDER COMMITTEE may procure, upon such terms and in such manner as it deems appropriate, goods/services similar to those undelivered and the contractor shall be liable to BLOCK TENDER COMMITTEE for any excess cost for such similar goods/services. However, the contractor shall continue the performance of the contract to the extent not terminated.

11) Blacklisting. The firm shall be black-listed, if it is found that:-

- i) Forged documents are submitted OR
- ii) If it becomes responsive on the basis of submission of bogus certificate/information. OR
- iii) In case of non-supply of materials or supply of substandard quality or supply of materials found to have been previously used or having reconditioned parts.

12) Bidder shall not have been debarred/black listed by The central Govt./state Govt./ Public sector undertaking/any other Local body. If in future, it comes/brought to the notice of The BLOCK TENDER COMMITTEE, during the tenure of this contract, that any disciplinary/penal action is taken against the bidder due to violation of terms and conditions of the tender allotted to Bidder. The bidders / manufactures which amounts to cheating/depicting of amplified intention anywhere in The BLOCK TENDER COMMITTEE, KORUKONDA or either by any of central Govt./state Govt./Public sector undertaking/any other Local body, The BLOCK TENDER COMMITTEE, KORUKONDA will be at discretion to take appropriate action as it finds fit.

13) **Repeat Order:** The quantity as detailed in the scope of supply may exceed to the extent of 100% for one calendar year to the distinction of administrative power accorded by the Tender Inviting Authority as the case deemed fit. In case of excess requirement, a separate supplier order will be issued to the successful bidder with due intimation.

13) All the above conditions should be strictly adhered to failing which the tender will be treated as non-responsive and no correspondence will be entertained in the matter.'
