6. **Earnest money deposit:** 1% (One per cent) of the bid value in shape of Post Office Term Deposit / Short Term Deposit / N.S.C. / KVP / Deposit receipt of any schedule Bank duly pledged in favour of Block Development Officer, Podia. The Tender Paper without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D. is also inadmissible.

7. **Documents to be attached:** The following documents should be furnished with the tender papers failing which the tender will be liable to rejection..

a) Self attested copy of valid Contractor Registration Certificate.

b) Self attested copy of valid PAN card/VAT/GST clearance certificate.

c) Original money receipt granted by BDO, Podia towards cost of Tender Paper.

d) Self attested copy of valid Caste Certificate issued by competent authorities in case of S.C. / S.T. contractors desirous of availing preference.

e) The bidders have to produce an original affidavit in support of the authenticity of documents including etc., attached with the tender paper.

f) The name of the project for which tender paper is filled should be written in **CAPITAL LETTERS** on the cover in which all the required papers are kept and sealed.

g) Joint venture consortium agreements are not allowed to participate in tender.

8. Shortfall of any required document(s) and EMD, Tender Paper is liable for rejection.

9. **Additional Performance Security Deposit:** Additional performance security shall be deposited by the bidder at the time of agreement, when the bid amount is less than the estimated cost put to tender.

10. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

11. On review of the last performance of the works executed through B.D.O, Podia previously, the lowest - 1 tenderer may / may not be considered for the works, though he / she becomes lowest -1 tenderer.

12. The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.

13. **The work should be qualitative, completed and handed over to JE/AEE latest by 05.08.2023 as per direction of Government of Odisha 5T Secretary, Collector, Malkangiri, CDO-EO, ZP, Malakngiri as inauguration date is 15.08.2023 for completion of other related work such as Electrical Installation work, PHD installation work, Fixing of High desk bench and fixing of smart TV etc.**


