

3. In tender documents mentioned in clause -7 may be read as "The rate shall be quoted in words" instead of "The rate shall be quoted in works"
4. In tender documents mentioned in clause -9 may be read as "Income Tax Return & GST Clearance certificate" instead of "Income Tax Clearance & Sales Tax clearance Certificate respectively."
5. In tender documents mentioned in clause -48 may be read as "%3 ("B" and above)" instead of "4% ("C" & "D" Class)/ 5% ("B" and above)"
