Sealed Tenders in prescribed format are invited from intending registered firms / Authorized dealers / suppliers to tender their rate for supply of following items, as per specification for distribution of the same to the 140 No. of House Hold of Beneficiaries (Women) of Malkangiri District, for Azolla cultivation in their back yard to feed their cattle for the year 2021-22.

The intending bidders are required to send their Tender in the prescribed format indicating cost price per unit piece, individual item wise, to the Office of Chief District Veterinary Officer, Malkangiri, in sealed envelopes by speed post / by person from 15 (fifteen) days of publication of this notice. The last date of submission of Tender is 08.7.23 3 PM

The sealed tender will be opened at 4 PM on same day at the office chamber of Chief District Veterinary Officer Malkangiri, in presence of selection Committee and in presence of bidders or their authorized representatives.

The cover of the individual sealed Tender must be superscribed at top, as "Tender for the supply of Silpaulin/ single-super phosphate (SSP)/ neem-based pesticides/ plastic buckets/ strainer etc.




