

Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State failing which the bid security shall be forfeited the said bid stands cancelled..
3. The Bid documents shall be available in the website: <https://tendersorissa.gov.in> from **15.05.2018 at 09.00A.M.** The bid document can be downloaded from website, for submission of the bid in the prescribed format, by the intending bidder. The bid cost shall be non-refundable.


4. Bids shall be received only "on line" on or before **22.05.2018 up to 05.00 P.M.** The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class- III and should follow the changes/ modifications/ addendum to DTCN if any.
5. Bidders should remit the Cost of Tender Paper and Earnest Money Deposit through NEFT/RTGS payment using internet banking of the bank in which the bidder holds his account, by adding the account number as mentioned in the challan as an interbank beneficiary.
6. **Bids received on line on due date and on time shall be opened at 11.00 Hours on 26.05.2018 in the office of Executive Engineer, RWS&S Division, Malkangiri in the presence of the bidders or their authorised representations who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.**

After the date & time of receipt of bid in on-line is over, the bidders must submit the hard copies of all the documents that have been uploaded in the e-tender portal in the office of the Executive Engineer, RWS&S Division, Malkangiri failing which the bid will be rejected.
