**TERMS & CONDITION FOR SUPPLY OF LABORATORY
CHEMICAL & LOGISTICS MATERIALS FOR R.N.T.C.P.,
MALKANGIRI**



1. The quotation should reach to the office of the undersigned clearly super scribed as "QUOTATION FOR SUPPLY OF MDR DRUG UNDER RNTCP, MALKANGIRI, QUOTATION CALL NOTICE NO. 8842 DATE : 10/10/18 " by Speed Post./Regd. Post/Courier by 25/10/18 by 4.00 PM and it will be opened on 25/10/18 at 5 PM in presence of the bidders or their authorized representatives of any bidder fails to be present, there is no bar for opening of quotation.
2. Interested parties can obtain quotation paper in any working day within office hour from RNTCP, Malkangiri. Such bidder can download the tender paper from the website www.malkangiri.nic.in.
3. The supplier need to mention the make/brand of the item quoted by him, otherwise the quotation will liable to be rejected.
4. Items should be quoted as per specification of tender. If there is any deviation in item quoted it should be clearly indicated.
5. Income tax PAN card must be submitted along with quotation otherwise the quotation liable to be rejected.
6. GST Registration must be submitted along with quotation (if in case not non registration the bidder should submit an undertaking for zero percentage or nill GST) otherwise the quotation liable to be rejected
7. The quoted price should be includes of all taxes and duties i.e. freights, insurance and transportation charges to RNTCP, Malkangiri.
8. The tender need to write the unit price in both figure & in word otherwise it will be liable to rejected. **If there is any discrepancies in unit between figure & words the amount mentioned in words would be prevail over the figure.**
9. Delivery of the items should be FOR destination to the different health institutions of Malkangiri district.
10. The supply should be completed within 21 days from the date of issue of supply order.
11. If any information of document furnished be the tender is found to be incorrect or misleading at any stage the tender will be rejected.
12. The supplier need to submit original tender paper signed on each page as acceptance to terms & conditions of the quotations; otherwise the quotation will be rejected.
13. The CDMO, Malkangiri reserves the right to reject any or all the quotations without any reason thereof.
14. Any quotation not super scribed as mentioned above will be not considered.
15. Affidavit with regard to not been blacklisted by any Govt. Organization.
