1.4 No tender documents can be accepted after the expiry of scheduled date and time for receipt of bids.

1.5 The scope of work shall include Supply, Installation, Commissioning, & Satisfactory demonstration. This will also include testing, packing, transportation, scheduling of transportation, transit insurance, delivery at sites, unloading, storage, job site storage, insurance, installation any other services associated with the delivery of the equipment and materials providing warranty of services and operation and maintenance of other related equipment / items required for complete installation. The successful bidder will assume full responsibility of the complete system until final acceptance.

10. Turn Key Job:

the responsibility of the vendor and the same will be made good by him. Related malba will

be removed by the contractor and will be disposed in the dumping yard.

Other related electric work, if any, for making the manifold functional will be executed by

the vendor.

• All civil/electrical work will be carried out as per specifications.

No payment will be made to the supplier, if he has not deposited the unconditional performance security in shape of State Bank of India demand draft amounting to 10% of the purchase order value which will be deposited in favour of <u>Chief District Medical and Public Health Officer payable at State</u> <u>Bank of India, Malkangiri</u> with the warranty for 1 year agreement to the consignee.

90% of the cost of the equipment (excluding CMC Cost)+100% turnkey +100% tax shall be released to the supplier on receipt of stock entry certificate and installation certificate (that it is working) from the consignee. UP-TIME BALANCE:
