TERMS & CONDITION:-

- 1. Cost of tender paper:-** Tender documents for the individual work may be obtained from the Bonda Development Agency, MUDULIPADA as per annexure on payment towards cost of tender paper in shape of Bank draft drawn in any Nationalized Bank in favour Project Leader, Bonda Development Agency, Mudulipada payable at State Bank of India, Chitrokonda / Balimela of Malkangiri Dist.
- 2. SALE OF TENDER PAPER:-** Tender documents will be sold from **30.12.2018** to **13.01.2019** upto **1.30 PM** only in working days only.
- 3. Date of receipt of tender paper:-** Tender paper in complete shape will be received till **17.01.2019** up to **5.00 P.M** (working days only)in the office of the Project Leader, Bonda Development Agency, Mudulipada through **REGISTERED POST**. Tender received by post after the stipulated date and time mentioned above will not be considered. Further that no tenders will be received by hand or by courier service.
- 4. Date of opening of the tender Paper:-** The Tender shall be opened on **18.01.2019** at **11.00 A.M** in the office of the Project Leader, Bonda Development Agency, Mudulipada in presence of the bidders or their authorized representatives having written authorization for the purpose alongwith all relevant original documents and the tender committee.
- 5. Earnest money deposit:-** 1% (one percent) of the bid value in shape of Post office term Deposit / Short term deposit / National Saving Certificate / Kisan Vikas Patra / Deposit receipt of any nationalized Bank duly pledged in favour of Project Leader, Bonda Development Agency, Mudulipada, after taking due written permission from him.

6. The following documents should be furnished with the tender paper failing which the tender is liable for rejection.

- Earnest money Deposit pledged in favour of Project Leader, Bonda Development Agency, Mudulipada,
 - Attested copy of valid Contractor Registration Certificate,
 - Attested copy of valid PAN Card / VAT clearance certificates.
 - Attested copy of valid labour license,
 - Original money receipt granted by P.L, B.D.A, Mudulipada towards cost of tender paper
 - The bidders have to produce an original affidavit in support of the authenticity of documents including EMD etc., attached with the tender paper,
 - The Engineer Contractors desirous of availing exemption of EMD should submit an original affidavit as regards the fact of availing award of work without submission of EMD/ISD during the current financial year, otherwise their tender paper will be liable for rejection.
 - The SC/ST contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate; otherwise their tender will be liable for rejection.
 - Joint venture consortium agreements are not allowed to participate in tender.
 - A critical analysis and working procedure should be submitted along with bid paper if the quoted amount is less than the estimate cost by more than 10% for examination by the committee,
 - The name of the project for which tender paper is filled should be written in **CAPITAL LETTERS** on the cover in which all the required papers are kept and sealed.
8. **Additional performance Security Deposit:-** Additional performance security shall be deposited by the bidder along with tender paper, where the bid amount is seriously unbalanced i.e less than the estimated cost by more than 10% and within 15%. In such case /event the bidder should have to deposit the APSD amount to the extent of 1.5 times of the differential cost of the bid amount and 90% of the estimated cost in shape of Post office term Deposit / Short term deposit / National Saving Certificate / Kisan Vikas Patra / Deposit receipt of any nationalized Bank duly pledged in favour of Project Leader, Bonda Development Agency, Mudulipada alongwith tender paper, otherwise the tender paper is liable for rejection.
9. Shortfall of any required document(s), draft(s) and EMD, tender paper is liable for rejection,
10. If the date of sale, receipt and opening of the tender as specified above happens to be holiday(s), then the process of sale, receipt and opening whatsoever will be shifted to immediate next working day at the same specified time and venue respectively without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to Notice Board at Panchayat Bonda Development Agency, MUDULIPADA only.
11. The details of successful bidders against each work will be displayed in the notice board. The successful bidder will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of acceptance letter.
12. The EMD amount is to forfeited if the tender backs out from the offer acceptance of tender by the competent authority.
13. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
