The Vehicle must be in Road Worthy condition, shall <sup>not</sup> be ~~more~~ <sup>more</sup> than ~~3 years old~~ <sup>the vehicle</sup> from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, fitness Certificate, valid Contract Carriage Permit(Commercial), proof of up to date tax payment etc. which are mandatory for plying of vehicle. make
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of Tahsildar, Khairput and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rent of hire charge be quoted including driver
6. The Vehicle must achieve a fuel efficiency of 12 Km per liter.
7. The details of the make and year of manufacture of the vehicle, registration no, mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender(**Annexure-III**).
8. The vehicle should be repaired immediately as and when required by the vehicle owner/ bidder .

**Annexure- II**

**TERMS & CONDITIONS FOR HIRING OF VEHICLE**

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly basis.

1. The hired vehicle, during period of contract, shall have all necessary valid M.V documents such as:- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract carriage Permit, proof of up to date tax payment etc. and D.L of the driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. **The maximum hire charges @ Rs. 18,000/-** (Rupees Eighteen Thousand) only is to be paid for **monthly basis (excluding fuel cost)** in every succeeding month subject to allocation of funds.
3. POL should be supplied separately by the office concerned. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc, taxes will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the bidder/owner.
5. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
6. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other sources.
7. In case emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. The driver of the vehicle will maintain log book of his vehicle regularly.
9. The Vehicle should be at the disposal of the hirer (both working days and holidays).
10. The vehicle will be engaged initially for 09 months i.e from 1.04.2019 to 31.12.2019 and it will be renewed time to time if runs smoothly to the satisfaction of the hirer.
11. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
12. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
13. In case the owner/bidder intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
14. If the bidder violates any on the terms of contract, Government shall forfeit the entire amount of security deposit.
