#### TERMS & CONDITION

1. Cost of tender paper:- Tender documents for the individual work may be obtained from the Block office, Khairput as per annexure on payment towards cost of tender paper in shape of Bank draft drawn in any Nationalized Bank in favour of Block Development Officer, Khairput payable at State Bank of India, Khairput of Malkangiri District.



2. **SALE OF TENDER PAPER:-** Tender documents will be sold from **05.12.2019 to 12.12.2019** from **10.00AM to 05.00PM**(working days only).
3. **Date of receipt of tender paper:-** Tender paper in complete shape will be received from **05.12.2019 to 13.12.2019** from **10.00 A.M. to 1.00 P.M.** ( working days only)in the office of the Block Development Officer, Khairput through **REGISTERED POST**. Tender received by post after the stipulated date and time mentioned above will not be considered. Further no tenders will be received by hand or by courier service.
4. **Date of opening of the tender Paper:-** The Tender shall be opened on **13.12.2019** at **3.30 P.M** in the office of the Block Development Officer, Khairput in presence of the bidders or their authorized representatives having written authorization for the purpose along with all relevant original documents.
5. **Earnest money deposit:-** 01% (one percent) of the bid value in shape of Post office term Deposit / Short term deposit / National Saving Certificate / Kisan VikasPatra / Term Deposit of any nationalized Bank duly pledged in favour of Block Development Officer, Khairput
6. **The following documents should be furnished with the tender paper failing which the tender is liable for rejection.**
  - a) Earnest money Deposit pledged in favour of B.D.O, Khairput
  - b) Attested copy of valid Contractor Registration Certificate.
  - c) Attested copy of valid PAN Card / GST clearance certificates.
  - d) Attested copy of valid labour license for the above project only (During Agreement for successful bidders).
  - e) Original money receipt granted by B.D.O, Khairput towards cost of tender paper.
  - f) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD etc., attached with the tender paper.
  - g) The Engineer Contractors desirous of availing exemption of EMD should submit an original affidavit as regards the fact of availing award of work without submission of EMD/ISD during the current financial year, otherwise their tender paper will be liable for rejection.
  - h) The SC/ST contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate; otherwise their tender will be liable for rejection.
  - i) Joint venture consortium agreements are not allowed to participate in tender.
  - j) The name of the project for which tender paper is filled should be written in **CAPITAL LETTERS** on the cover in which all the required papers are kept and sealed.
7. **Additional performance Security Deposit:-**Additional performance security shall be deposited by the successful bidder within seven working days from the date of award of work. Where the bid amount is seriously unbalanced i.e less than the estimated cost put to tender. in such an event, the bidders who have quoted less bid price/rates than the estimated cost put to tender minus the quoted amount as A.P.S.D. in shape of N.S.C. / K.V.P./ Demand Draft / T.D.R. duly pledged in favour of Block Development Officer, Khairput . otherwise the Tender Paper is liable for rejection.
8. Shortfall of any required document(s), draft(s) and EMD, tender paper is liable for rejection.
9. If the date of sale, receipt and opening of the tender as specified above happens to be holiday(s). then the process of sale, receipt and opening whatsoever will be shifted to immediate next working day at the same specified time and venue respectively without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to Notice Board at Panchayat Samiti, Khairput only.
10. The details of successful bidders against each work will be displayed in the notice board. The successful bidder will collect the letter of acceptance from the office of the undersigned within seven days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non-receipt of acceptance letter.
11. The EMD amount is to forfeited if the tender backs out from the offer acceptance of tender by the competent authority.
12. The appropriate GST shall be paid extra on Tender bid amount of the said projects as and when applicable as per the Govt. Norms.
13. The Tender Paper shall not be sold to the defaulting contractors.
14. The undersigned reserve the right to cancelled/reject the tender of one or of all with or without assigning any reason thereof.
