No** \_\_\_\_\_ (to be filled) Separate tender are required to be submitted for separate vehicles under auction above. The tenders will be opened on the same date i.e dtd. 30.06.2020 at 3.00PM. in presence of the Tenders of their authorized representatives with Electoral Photo and Identity Card. The successful tenderers shall have to deposit 25% of the Quoted amount and full Tax amount under GST or as per the rule in force immediately after the announcement of the tender result and the rest amount within 7 days from the date of notification of sale and case of Un successful Tenderers the EMD will be refunded soon after the declaration of the result.

In case of default in payment of highest Tender amount by the successful Tenders within the Stipulated Period, the EMD and deposited amount shall be forfeited to Govt. and the vehicle will be put to fresh Tender sale. The clearance of Road Tax etc. Shall be responsibility of the successful tenderers. The Undersigned reserves the right to either accept or reject any Tender without assigning any reason thereof.

The intending Tenderers would inspect the vehicles lying in deferent places as noted below on any working day during office hour and relevant papers before Tender sale and no compliant shall be entertained after the Tender sale is completed. Once the sale is rectified in the name of the highest Tenderers all the liabilities, if any will be of the Tenderers & no clams for any paper which are not available in this office will be entertained. Once the tendere files the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle, liabilities of availability of the relevant paper of the said vehicle. The Undersigned is not bound to accept the highest tender and reserve the absolute right to accept any tender of reject any or all trenders without assigning any reason thereof. The intending tenderers are required to submit copy of Voter identity Card, Aadhar card or any other authentic identity for there identification along with the tender paper.

The successful tender shall lift the vehicles form the site within 7 days from the date of depositing the full tenders amount, falling which ground rent@1% of tender money shall be charged for each day or part of the day till lifting of the vehicle from the site. Custody or safe guard of the vehicle shall be the responsibility of the tenderers and no clam or compliant on that account shall be admissible. Where the ground rent so charged exceeded the sale price deposited, the Tenderers shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become the property of Govt. and will be free from all encumbrances and dispose off by fresh sealed tender as the case may be.
