- Bidders should remit the Cost of Tender Paper and Earnest Money Deposit through NEFT/RTGS payment using internet banking of the bank in which the bidder holds his account, by adding the account number as mentioned in the challan as an interbank beneficiary.**



If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The 1<sup>st</sup> lowest bidder must submit the hard copies of all the documents that have been uploaded in the e-tender portal for verification in the office of the Executive Engineer, RWS&S Division, Malkangiri when intimated failing which the bid shall be rejected.
