In pursuance to this office letter No. 1549 dated 12.08.2020 for expression of interest (EOI) for audio visual/video documentation/wall paintings/kalajathas (Road shows) etc. under NFSM, OMM and ATMA for the year 2020-21, the following points under list of documents to be submitted may please be treated as optional. The rest of the points remains unchanged.

4. The agency must have conducted documentation and preparation of video CDs for at least 10 to 15 similar agricultural assignments under Department of Agriculture and Farmers Empowerment, Govt. of Odisha during the last 3 consecutive financial years may be treated as optional.

5. The agency must have been empanelled under I&PR Department or Department of Agriculture and Farmers Empowerment, Odisha may be treated as optional.

10. The audit reports for the last 3 consecutive financial years i.e. 2016-17, 2017-18 and 2018-19 may be treated as optional.

The bidders/Agency must submit the quoted rate for vide documentation per minute should be within Rs.2,000/- and the Kalajathas (Road shows) is excluded from this EOI.

The EOI documents must be submitted in this office latest by **29.08.2020 upto 5.30 P.M.** through speed post/registered post in closed cover. The B.D. for Rs.1000/- should be deposited in favour of the Chief Dist. Agriculture Officer, Malkangiri. The EMD amount of Rs.5000/- should also be deposited in shape of B.D by latest by 29.08.2020 in favour of the Chief Dist. Agriculture Officer, Malkangiri. The date and time for opening of bidding is fixed to **31.08.2020 at 3.00 P.M** in the Office of the undersigned in presence of 70% of the bidders/members of the committee. The bidders or their representatives should remain present in this office at the time of opening of bidding and to produce their original documents for verification.
