- Every intending bidder will have to deposit **Rs.15,000/-** (Rupees fifteen thousand) only in advance as Cash/ Banker Cheque/Bank Draft in favour of Commandant, 160 Bn BSF payable at SBI Malkangiri as earnest money at least one hour before the scheduled time of auction, which will be adjusted/refunded after finalization of auction on the same day.
