Sealed Tender Paper will be received from From 02.12.2020 to 11.12.2020 (except- 05 & 06 Dec -2020) up to 5.30 P.M on working day only in the Office of the BDO, Kalimela through registered post /speed post only. The tender Paper received after the stipulated time will not be considered. No tender paper will be received by hand or by courier service. The tender papers shall be opened on 14.12.2020 at 11.00 AM onward in the office chamber of BDO, Kalimela. in presence of the bidders or their authorized representatives having written authorization for the purpose.

3. The following documents should be furnished along with the tender papers and to show the original documents during tender opening time failing which the tender will be liable for rejection.

(a) EMD as specified above in shape of Deposit receipt of schedule bank/KVP / NSC /POTD/ STD/ Term deposit duly pledged in favour of BDO, Kalimela

(b) Attested copy of the Contractor Registration/labour licence/ PAN card / GST clearance Certificate & original money receipt granted by BDO, Kalimela towards cost of Tender Paper to be enclosed with the tender paper.

(c) The engineering contractor desirous of availing exemption of EMD should submit an affidavit that he has not availed the same thrice within the current financial year with supporting evidence.

(d) SC/ST Contractor desirous of availing concession in EMD and preference should submit an affidavit that he has not availed the same thrice within the current financial year and attested copy of recent caste certificate.

(e) Additional Performance Security Deposit: If the bidder has quoted their rate less than tender value and eventually gets the tender, then he/she shall deposit the less amount (A.P.S.D) in shape of POTD pass book /term deposit/KVP/NSC/Deposit receipt deposit in any nationalized bank duly pledged in favour of BDO, Kalimela at the time of drawl of F2 Agreement.

(f) An affidavit in support of the authenticity of the document including no relation certificate and detail work programme should be attached with the tender paper.

4.The defaulter contractors who have failed to execute projects of this block/backed out from execution process/delayed in execution and poor performance/those who have abandoned the project midway will not be allowed to participate in the tender process. if any of such contractor participates then his papers will not be considered at all.
