- (A) The Bid has been invited under two bid system i.e. "Technical Bid". The interested Bidders are advised to submit two separate sealed envelopes super scribing Technical Bid and Financial Bid.
- (B) Technical Bid and Financial Bid- The Bidders have to fill up the Technical Bid form (Format-A) (Copy enclosed) and submit it with a separate envelope with self-attested documents. Similarly, the Financial Bid form has to be filled up as per prescribed form (Format-B) (Copy enclosed) and to be submitted in separate envelope.
- (C) The Tender should be addressed to the Additional District Magistrate, Malkangiri, Nizarat Section, Collectorate, Malkangiri At/Po/Dist- Malkangiri-764045 and super scribing as Tender for supplying.....(Name of the item / category).
- (D) The Tenderers / Firms have to submit EMD of 3% of total estimated cost only in shape of Demand Draft payable to Assistant Collector, Nizarat, Collectorate, Malkangiri in the Tender Bid.
- (E) The interested Bidder has to enclose self-attested photo copy of the following documents in the technical bid envelope, stated above, such as:

  - (x) The bidder should have Trade Mark Registration issued by the Government of India for the product offered in the Tender.

  - (xii) If bidder is a distributor, he/she should have an authorization letter from the brand owner/ company/ OEM to showcase the trade mark registration issued by the Government of India for the product offered in the tender.

- (O) There shall be no compromise of the quality of materials as approved by Purchase Committee.


**2. Submission and opening of Tender:**


