- (B) Technical Bid and Financial Bid – The Bidders have to fill up the Technical Bid Form (Format-A)( copy enclosed)and submit it with a separate envelope with self attested documents. Similarly the Financial Bid form has to be filled up as per prescribed form ( Format-B) (copy enclosed) and to be submitted in separate envelope.
- (C) The Quotation should be addressed to Principal, Govt. Science Higher Secondary School, Malkangiri, AT/PO/DIST- Malkangiri-764045, and super scribing as Quotation for supplying .....(Name of the Item/Category).
- (D) The Firms have to submit EMD of Rs. 26800 /- only in shape of Demand Draft payable to Principal, Govt. Science Higher Secondary School, Malkangiri in the Quotation bid.
- (E) The interested bidders has to enclose self- attested photo copy of the following documents in the technical bid envelope, stated above, such as:
