Terms and Conditions

1. Tender documents for the individual work may be obtained from the office of the Block Development Officer, Podia on payment of cost (non-refundable) of the tender paper in shape of Demand Draft (DD) drawn any nationalized bank in favour of Block Development Officer Podia.

2. The Tender Papers will be sold from dt. 31/03/2021 to dt. 09/04/2021 (excluding the holidays) during Office hour from 10 A.M. to 5.30 P.M.) Only in the office of the BDO, Podia. Last date for receiving of Sealed Tender Paper will be dt.09/04/2021 up to 05.30 P.M. in the Office of the BDO, Podia through Registered Post / Speed Post only. The Tender Paper received after the stipulated time will not be considered. No Tender Paper will be received other than Speed Post / Registered Post. The Tender Papers shall be opened on dt.12/04/21 at 12.30 P.M. onward in the office chamber of BDO, Podia in presence of the Bidders or their authorized representatives having written authorisation for the purpose.

3. The following documents should be furnished along with the tender papers and to show the original documents during tender opening time failing which the tender will be liable for rejection.

- EMD as specified above in shape of Deposit receipt of schedule Bank /KVP /NSC / POTD Pass Book duly pledged in favour of BDO, Podia.
- Attested copy of the Contractor Registration / PAN card / GST clearance Certificate to be enclosed with the tender paper
- The Engineering contractor desirous of availing exemption of EMD should submit an affidavit that he has not availed the same thrice within the current financial year with supporting evidence.

(d) SC/ST Contractor desirous of availing concession in EMD and preference should submit an affidavit that he has not availed the same thrice within the current financial year and attested copy of recent caste certificate (issued within last one year)

(e) If Tenderer quoted by Tenderer is less than 15% of the Tendered amount, such Tender will liable to rejected. When the Tender amount is up to 10% less than the Tendered amount, no performance security deposit is required. Performance security shall be deposited by the tenderer if the tenderer quoted their rate less than the tender value. They should deposit the less amount in shape of POTD Pass Book /KVP/ NSC/ Term deposit in any schedule Bank /PO duly pledged in favour of BDO, Podia within 07 (Seven) days from the date of issue of notice by the undersigned, If he/ she will be found successful bidder for the respective project/ work during the scrutiny of tender documents.

(f) The tenderer quoting their rates less than the Tender value must have to submit their item wise analysis of rates with proper justification in support of their quoted rates along with the Tender paper.

(g) The contractor must have executed similar nature of works and financial turnover in last 3 years. Tenderers are required to submit the list of T & P Possessed along with supporting documents, list of works executed and successfully completion of Civil work during last 3 years. The above information should be certified by the Concerned Authority not below the rank of B.D.O / Asst. Executive Engineer.

(h) An affidavit in support of the authenticity of the document including no relation certificate and detail work programme should be attached with the tender paper.

4. The defaulter contractors who have failed to execute projects of this block/backed out from execution process/delayed in execution and poor performance/those who have abandoned the project midway will not be allowed to participate in the Tender Process. If any of such contractor participates then his papers will not be considered at all.

5. On review of last performance of the works executed through B.D.O, Podia previously the lowest-1 tenderer may/may not be considered for the works through he becomes lowest -1 tenderer

6. The tender papers will be received through Registered post & Speed post only. No Tender paper will be received by hand or by Courier Service. The undersigned will not be responsible for any delay in Postal Service.

7. Short of any required document with the Tender Papers and late submission of any documents is liable for rejection.

8. The authority reserves the right to negotiate or reject any or all the Tenders, modify or cancel any condition of Tender in the interest of the Government with or without assigning any reason thereof.
