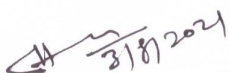

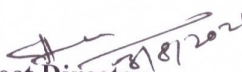

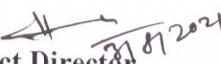

Expression of Interest (EOI) for audio visual and video documentation under NFSM, OMM and ATMA for the year 2021-22

Expression of Interest (EOI) is hereby invited by the Project Director, ATMA Malkangiri from the intending bidders/reputed firms for **audio visual and video documentation** on different schemes i.e. under NFSM, OMM and ATMA implemented under agriculture sector in Malkangiri District for the year 2021-22. The EOI documents must be submitted through **registered post/speed post/courier** service latest by **07.08.2021 upto 12.00 p.m.** and the EOI will be opened on the same day i.e. **on dated 07.08.2021 at 3.00 p.m.** the EOI should reach in a sealed cover with super scribing as EOI for video documentation under different schemes of Project Director, ATMA, Malkangiri along with DD No, date and amount towards EMD and bidding processing fees. The EOI should contain two envelopes, one for technical bid and another for financial bid. The DD/banker's cheque towards EMD amount and processing fees should be enclosed with the financial bid and all other documents should be enclosed in the technical bid.

Terms and Conditions Under EOI:

- The agencies will abide by the terms and conditions laid down herewith and any other condition prescribed by the Project Director, ATMA Malkangiri from time to time in fulfillment of its objective.
- This Empanelment would not in any way mean that the undersigned would be paying any retainership fee or monthly consultancy charges or any other form of remuneration to the empanelled agencies.
- Project Director, ATMA, Malkangiri shall retain the absolute copyright and all such production related rights including the rights for adaptations, translation, reproduction, alteration and archiving without any restriction of time period of all such creative and their inputs which might be produced by the agency for executing a work. Such creative could be used in any such future campaigns that the Government may consider appropriate.
- The empanelled agencies by agreeing to these Terms and Conditions shall be liable for penalty as per the terms of this contract in the event of their failing to adhere to them.
- This EOI is not an offer and is issued with no commitment. The undersigned reserves the right to withdraw the EOI and change or vary any part thereof at any stage and also reserves the right to disqualify any bidder, should it be so necessary at any stage.

- The undersigned reserves the right to withdraw this EOI if it determines that such action is in the best interest of the Government.
- The bidding processing fee will be **Rs.2,000/- (Non-refundable)** should be deposited in shape of account payee banker's cheque/DD in the name of Project Director, ATMA, Malkangiri and payable at Malkangiri.
- Earnest Money Deposit (EMD) will be of **Rs.10,000/- (Refundable)** should be submitted in shape of account payee banker's cheque/DD in the name of Project Director, ATMA, Malkangiri and payable at Malkangiri for the selected party, the same will be treated as Security Money till the end of the contract period.

Average annual turnover for 4 (Four) consecutive financial years i.e. 2017-18, 2018-19, 2019-20 and 2020-21 **must be 40 lakhs or above** (turnover statement of the last 4 years certified by the appropriate authority is to be furnished). If the turnover for 2020-21 is not available then average turnover should be **40 lakhs or above for 3 (Three) consecutive financial years from 2017-18 to 2019-20**. The annual financial statement must be duly certified by the Chartered Accountant
4. The agency must furnish a copy of his/her GSTIN Registration Certificate.

5. The Agency must have conducted documentation & preparation of video CDs for at least 10 to 15 similar agricultural assignments under Department of Agriculture & Farmers Empowerment, Govt of Odisha during the last 3 consecutive financial years and should have conducted in at least **10 Districts of Odisha** (Copies of the work orders/Agreement to be furnished serially year wise).
