The sealed tender papers to be submitted to the CDM&PHO, Malkangiri on or before 05.10.2021 by Regd. Post / Speed post up to 5.00PM and the same will be opened on the dt 07.10.2021 at 11.00 AM.

Terms & Conditions for Disposal of Condemned EMAS Ambulances(108) through Tender Call Notice:

1. Condemned Ambulances are to be disposed off as per statement Annexed.
2. The participants may inspect the ambulances during the official working hours with permission from the CDM&PHO, Malkangiri / Medical Superintendent of Concerned CHC.
3. Ambulances will be auctioned in "As is where is basis".

Tender Forms:

4. The terms, conditions and guidelines for Bidders should not be submitted with the TENDER FORM. Only filled up tender form should be submitted.
5. Tender shall be submitted in the "TENDER FORM" Annexed.
6. The Bidders shall quote the rate visibly in words (Block Letters & Numerical) to avoid confusion.
7. Any mistake noticed in the Tender Form will be decided by the Tender Screening Committee and its decision will be final.
8. The Tender paper shall be submitted in sealed cover super scribed "TENDER FOR DISPOSAL OF CONDEMNED AMBULANCES(108) FOR 2021-22". Also mentioning details address on the left side of the cover with their Telephone No./ Mobile No. etc.
9. All Bidders shall submit the Tender by Registered Post / Speed Post only.

Tender Paper Cost:

Rs.500/- per Tender per ambulance shall be deposited in favour of CDM&PHO, Malkangiri in shape of bank draft from any nationalized bank.

Earnest Money:

10. Rs.2500/- (Rupees Two Thousand Five Hundred only) for each ambulance will be treated as EMD and the same will be submitted along with Tender Form. This draft will be drawn in favour of CDM&PHO, Malkangiri from any Nationalised Bank.
11. To facilitate immediate refund of EMD, the bidder should submit separate Bank Draft for each ambulance they have tendered. The EMD of second highest bidder shall not be refunded until the Successful bidder deposits the full amount and Tender is finally decided in his favour.
12. EMD of unsuccessful Bidder will be refunded after finalization of Tender and within 30 days and no interest will be claimed by the bidder.

13. Where a Bidder has submitted one Bank Draft covering more than one vehicle and if there is highest offer in respect of any vehicle, the Bank Draft will be retained till final decision of the conducting Authority.
14. Retention of EMD of the highest and second highest Bidder does not guarantee any decision in favour of the tenders. Decision of the conducting officer shall be final.
15. The bidder quoting the highest price or above the price approved by the authority will be asked to deposit 25% of the Tender Value on the day of opening of the Tender by open announcement.
16. On failure to make final payment (75%), the aforesaid deposit of 25% including the EMD of the Bidder shall be forfeited and the vehicle put to fresh auction or tender as the cases may be.
17. The Bidder should clearly mention their name and Designation, whether they may be Govt. / Private Organization.

Payment Etc:

18. On payment of total amount clearance will be issued by the CDM&PHO, Malkangiri
19. No dispose off value will be accepted without the presence of the successful bidder or their authorized agencies.
20. The condemned Ambulances will be handed over to the successful bidder of receipt of full payment of the accepted Disposed off value.
21. Tool implements and spare parts shall not be delivered. R.C Books etc which are not available shall not be delivered along with the ambulance.
22. The successful bidder shall have to take the ambulances from the respective sites within 7 days of finalization of tender process. Custody & Safety of the disposed off ambulances shall be the responsibility of the successful bidder after it is finalized.

Ground Rend

23. In case where the ambulance is not taken within the stipulated period ground rent@1% of the auction value shall be charged for each day or part of the day till the vehicle is removed from the site.
24. Where the ground rend so charged exceeds the sale price deposited by him sham be adjusted towards the ground rent and the vehicle shall become absolute property of the Government & free from encumbrances and may be disposed by fresh tender or as per decision of conducting authority.

Disqualification:

25. A tender may be summarily rejected by the screening Committee for the following reasons.
26. Tender not submitted in the prescribed Tender Form.
27. Tender received beyond the stipulated last date and time.
28. Tender not submitted in sealed Cover.
29. EMD falling short of stipulated amount or without EMD.
30. Sealed Tender paper of any of the absentee Tenderer may not be opened and returned to them with seal intact within 30 days.

Correspondence:

31. All correspondence including the legal complication of the Tender and disposal of the ambulances/vehicles are to be complied by the concerned CDM&PHO, Malkangiri.
32. Authority:
33. The authority reserves the right to accept or cancel any tender or all tenders without assigning any reason thereof and may be settle the auction with the highest bidder on negotiation.
34. In case of dispute on any matter the interpretation & discussion of the authority shall be final and binding and the legal procedures if any should be in the jurisdiction of Malkangiri district.
