The Block Development Officer, Korukonda invites sealed tender on behalf of Governor of Odisha from registered and eligible Contractors of the State P.W.D (R&B) / Water Resources / Rural Works / M.I. / C.P.W.D for the following works eventually to be drawn up in the P.W.D. F-2 forms in conformity with the Detailed Tender Call Notice.

- 1. Cost of Tender Paper :-** The tender specifications can be obtained from the office of the Block Development Officer, Korukonda on payment towards the cost of tender papers as mentioned above (Non-refundable) in shape of Bank Draft drawn in favour of Block Development Officer, Korukonda in any Nationalized Bank having its branch at Malkangiri on any working days from 10.12.2021 to 17.12.2021 (Except Sunday and Public holidays) for the above works.
- 2. Sale of Tender papers:-** The tender paper will be sold from 10.12.2021 to 17.12.2021 (Except Sunday and Public Holidays) at Block Development Officer, Korukonda during the above mentioned period between 10.00 AM to 5.30 P.M. on working days only.
- 3. Date of receipt and mode of submission tender paper :-** The tenderers have to submit the sealed tender papers in complete shape through Register Post /Speed Post only, by directly sending it to the Block Development Officer, Korukonda in his official postal address. The last date of receipt of tender paper is 18.12.2021 (5.30 PM). The undersigned will not be responsible for postal delay if any or non receipt of the paper in time. The tenderer must super scribe the name of the work/ Project on the sealed envelope.
- 4. Date of Opening of Tender Paper:** The tender papers shall be opened on **20.12.2021** at **11.00AM** in the presence of the tenderers or their authorized representatives having written authorization for the purpose and the tender committee.
- 5. Earnest money deposit:** 1%(One Percent) of the bid value in shape of Post Office Term Deposit/ Short Term Deposit / N.S.C./KVP/Deposit receipt of any nationalized bank duly pledged in favour of Block Development Officer, Korukonda. The Tender Papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D. is also inadmissible.
- 6. Documents to be attached:** The following documents should be furnished with the tender papers failing which the tender will be liable for rejection.
 - a) E.M.D. pledged in favour of the Block Development Officer, Korukonda.
 - b) Self attested copy of Contractor Registration Certificate.
 - c) Self attested copy of PAN card/VAT clearance certificate.
 - d) Original money receipt granted by BDO, Korukonda towards cost of Tender Paper.
 - e) Self attested copy of Caste Certificate issued by competent authorities in case of S.C. / S.T. contractors desirous of availing preference.
 - f) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD, etc., attached with the tender paper.

- g) Affidavit as regards the fact of availing award of work without submission of E.M.D./I.S.D. during the current financial year in case of Engineer Contractors desirous of availing exemption of E.M.D., otherwise their tender paper will be liable for rejection.
- h) The name of the project for which tender paper is filled should be written in **CAPITAL LETTERS** on the cover in which all the required papers are kept and sealed.
- i) Joint venture consortium agreements are not allowed to participate in tender.

7. Shortfall of any required document(s) and EMD, Tender Paper is liable for rejection

8. Additional Performance Security Deposit: Additional performance security shall be deposited by the bidder at the time of agreement, when the bid amount is less than the estimated cost put to tender. The quoted amount as A.P.S.D. in shape of Post Office Term Deposit/ Short Term Deposit / N.S.C./KVP/Deposit receipt of any nationalized bank duly pledged in favour of Block Development Officer, Korukonda along with tender paper, otherwise the tender paper is liable for rejection.

9. Forfeiture: The E.M.D. amount will be forfeited, if the tenderer backs out from the offer acceptance of tender, by the competent authority.

10. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

11. On review of the last performance of the works executed through B.D.O, Korukonda previously, the lowest -1 tenderer may / may not be considered for the works, though he / she becomes lowest -1 tenderer.

12. The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.

13. If the date of sale, receipt of opening of the tender as specified above happens to be holiday(s), then the process of sale, receipt and opening whatsoever will be shifted to immediate next working day at the same specified time and venue respectively without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to Notice Board at Panchayat Samiti, Korukonda only.
