

Tender paper completed in all respects along with its enclosures should be received through Registered/Speed Post only at the Block Office, Malkangiri on or before **21.01.2022 up to 05.00 PM** in a sealed cover super scribed at top of the envelop in capital letters as **“TENDER FOR INSTALLATION OF TAMARIND PROCESSING UNIT FOR SHG AT AKUR WEEKLY MARKET.**

1. The tender documents should be submitted in two separate closed and sealed envelopes which should be super subscribed as first envelope meant for **TECHNICAL BID** and second for **FINANCIAL BID** in capital letters. The financial Bid will be opened only of the Tenderer whose Technical Bid is correct and complete as per Terms and Conditions.
2. The firm should have submitted self attested copy of valid GSTIN Certificate and up to date GST filing copy of relevant preceding month/quarter.
3. The firm should have submitted self attested copy of valid PAN with up to date clearance certificate of ITR filing.
4. The firm should have submitted self attested copy of Udyog Aadhar Certificate
5. The final selection of the Tender Item of any participating bidder is subject to the choice and decision of Tender Finalization Committee.
6. The tender paper will be opened in presence of members of the Block Tender Finalization Committee and Tenderer or his/her authorized representative as per the scheduled venue, date and time mentioned in Tender call notice.

8. The Committee will select and finalize the bidder taking in to account the price quoted by him/her .
9. Bidder must provide of MAFs (Manufacture Authorization Form) for all equipments quoted in the proposal.
10. The successful Bidder will maintain and up keep the supplied machineries for the period of 01 (one) year.
11. The eligibility of Bidder will be judged basing on its own or the OEMs credentials, In case the Bidder is channel partner, the respective OEMs has to authorize in writing on letter head to allow the partner in using it's credentials for eligibility.
12. OEMs / Channel partners of the OEMs can participate in the Tender. For execution of orders, OEM may declare in the manufactures authorisation form it's channel partner will be treated as supplier.
13. The bidder should not have been banned/ black listed as on date by any govt. agencies/ govt. departments/ PSU/ board/ council or similar organizations on grounds of non performance, fraud practice, financial irregularities. A self declaration on letter head of bidder duly signed and stamped by the authorized signatory to be submitted.
14. All hardware items must be Quoted with minimum 01(One) year onsite comprehensive manufacturers replacement Warranty. All bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation & Comprehensive maintenance of service.
15. The item shall be delivered and installed at Tamarind processing unit building at **Akur of Udupa G.P**, Malkangiri Block in good condition and to the satisfaction of tender committee.
16. The payment will be made to the firm after the certificate issued by the District Industrial Officer, Malkangiri. and submission of bills to the concerned SHG with receipt of Stock Entry Certificate and quality verification certificate before payment.
17. The provision of "Bid Security Declaration is kept for successful Bidder @ 5% of the cost of goods to be supplied.
18. The selected items should be delivered at Installation of Tamarind processing Unit for SHG at weekly market, Akur of Udupa G.P, Malkangiri block within one month from the date of issue of supply order.
19. The firm should have financial transaction of minimum one crore during last financial year.
20. In case of any dispute, the decision of the Block Development Officer, Malkangiri is final.
21. If any legal dispute arises, the jurisdiction of the matter is limited /subjected within Malkangiri District only.
