OFFICE QUOTATION / NOTICE INVITING TENDER

Sealed quotations / tenders are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing 01 (one) No. of Non AC / AC Diesel driven vehicle (Bolero / Scorpio) having sitting capacity not more than 10 (Ten) including driver, which shall conform to the Terms and conditions (Annexure-II) for official use of the Civil Supplies Officer-cum-District Manager, OSCSC Ltd., Malkangiri on monthly rental basis.

1. The vehicle must be in Road Worthy Condition, shall not be more than 3 (three) years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.
3. The driver should be well behaved gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the District Manager, OSCSC Ltd., Malkangiri payable at Malkangiri, and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the General bid information (excluding fuel).
6. The vehicle must achieve a minimum fuel efficiency of 10 K. Ms per liter for Non AC/ AC (**Bolero/Scorpio**).
7. The details of the make and year of manufacture of the vehicle, registration No. mileage (KMs covered per liter) and name of the driver with driving License No. period of validity should be specifically provided in the General Bid information to be furnished with Quotation /-Tender. (**Annexure-III**).
8. The Quotation complete in all respect should reach with the undersigned on or before 19.04.2022 by 5.00 P.M through Registered post and shall be opened on 20.04.2022 at 11.00 A.M. in presence of the bidders or their authorized representatives.
9. The application form of quotation / tender containing General Bid information & Terms and conditions for Hiring of vehicles etc. will be available in the office of the C.S.O-cum-District Manager, OSCSC Ltd., Malkangiri on payment of Rs. 1000/- (Rupees One thousand) only from **31.03.2022 to 18.04.2022 (up-to 1.00 P.M)**. The Bidders may also download the Tender Documents from the District Website i.e. www.malkangiri.nic.in In enclosing a Demand Draft of Rs. 1000/- towards Tender documents fees drawn in favour of the District Manager, OSCSC Ltd., Malkangiri, payable at Malkangiri.

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rental basis.

1. The hired vehicle during the period of contract, shall have all necessary valid MV documents such as: - valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Permit, proof of up to date tax payment etc. and D.L. of the driver available all the times. The Office of the CSO-cum-District Manager, OSCSC Ltd., Malkangiri hiring the vehicle shall not be responsible for any damage / loss caused to the hired vehicle or loss of life / injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The owner of the vehicle / bidder shall be responsible for all such litigation.
2. The hire charges to be paid on monthly basis is final but does not include cost of diesel and lubricants. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating Oil of Engine, Gear box & different Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever, the replace of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
5. In case of the vehicle do not report regularly the authority will be at liberty to reject the agreement and may engage vehicle from other resource.
6. The vehicles shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of submission of bills by the agency and no advance payment will be made to this effect.
9. The vehicle shall not be more than 3 years old from the initial date of registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one-month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement. It shall be mandatory upon him to grant one-month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, the CSO-cum-District Manager, OSCSC Ltd., Malkangiri shall forfeit the entire amount of security deposit.


