1. The bidder is required to submit a Bank Draft / DD worth Rs.500/- (five hundred) only for Tender Paper cost and Rs. 20,000 (Rupees Twenty thousand) only in favour of Dist. Child Protection Officer, Malkangiri payable at UBI, Malkangiri towards the EMD cost.
2. Sealed quotations in two different envelopes (marked as Technical Bid & Financial Bid) containing the details as prescribed here are to be submitted by the bidder. The Technical Bid envelope should contain the followings: (a). Registration certificate of farm/ Authorized Dealer/ Supplier/Manufacturer. (b). Copy of bid documents along with the annexure duly signed by the bidders at the bottom of each page. (c). Xerox Copy & Self Attested of PAN card. (d). Xerox Copy & Self Attested GST certificate. (e). Income tax returns filed for the last two financial years (f). Self-declaration for supply of IEC Boards & Hoardings as per requirements of the DCPU, Malkangiri (g). The envelope must be sealed with the names & addresses of the bidders clearly mentioned on the front side. (h). Any bids received without all the documents shall be rejected. (i). The IEC boards & hoardings are installed as per plan. (j). If delivery is not made as per the date, the authority has the right to fixed penalty of 05% on the total cost. (k). Payment shall be made after successful installation of goods in satisfactory condition after verification by the Tender Committee and production of an authorized GST Bill. (l).
