

The Divisional Forest Officer, Malkangiri Division on behalf of Governor of Odisha invites **Percentage Rate bids in single cover system** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-4 (four) registered with the State Governments and Contractors of equivalent Grades /Class Registered with Central Government / MES / Railways for execution of **Building works (Composite works)**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement. The bidder may submit Bids for the following works.



- 2) i) The Bidders shall **transfer online Earnest Money Deposit/ Bid Security** of the amount specified for the work in the **Col.6** of the table above as a part of its bid through a process as mentioned in DTCN.  
ii) Bidders desirous to hire machineries or equipment from outside the State or owned but deployed outside the state are required to transfer online 2% of the amount put to tender as Bid security.
- 3) The Bidders shall transfer online the cost of Bid Documents as mentioned in **Col.7** of table above towards the cost of bid through a process as mentioned under DTCN.
- 4) The Bid documents will be available in the website [https://tendersodisha.gov.in/nicgep/app.](https://tendersodisha.gov.in/nicgep/app) from **18.00 hours of 20.10.2023 to 17:00 Hours of 30.10.2023.**
- 5) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class III or Class IV.**
- 6) *Bids shall be received only "On-line" on or before 17:00 Hours of dtd.30.10.2023.*
- 7) Bids received "on-line" shall be opened **at 11:30 Hours on dtd. 31.10.2023** in the office of the **Divisional Forest Officer, Malkangiri Forest Division, Odisha** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 8) Bidders are to submit only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification Multiple BoQ submission shall lead to cancellation of bid.
- 9) The online bidder shall have to produce the original documents for verification in support of scanned copies and statements uploaded in the portal within three days from the date of opening of the bid.
- 10) As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule of rates
- 11) Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provision
- 12) The items covered in **Clause No-122 of DTCN** for roads and building works are required as essential criteria for eligibility for qualification. Checklist should be duly filled in.
- 13) This notice is to be read with all the Clauses / addendum to the "Procedure to participate in online bidding". Any corrigendum / Addendum will be displayed in the website [https://tendersodisha.gov.in/nicgep/app.](https://tendersodisha.gov.in/nicgep/app) only.
- 14) The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit scan copy of the affidavit for the same along with tender documents; otherwise, they will not be entitled to avail such facilities.

- 15) If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.
- 16) Any tenderer desires to avail any facility as per certain circular /order of Govt. have to apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
- 17) Authority will not be held responsible for any technical problem/ failure of network, server during the schedule dates of online bidding.
- 18) Conditional tender will be summarily rejected. The Authority reserves the right to reject any or all bids without assigning any reason thereof.
- 19) As per OPWD code **clause 12.4 (Appendix-IX(A))** the contractors participated in the above tender mandated to **register themselves in Contractor Data Base Management System (CDMS) available at [www.cdmsodisha.gov.in](http://www.cdmsodisha.gov.in).**
