#### Bid Price:

- Transportation charges to be included in the Bid Price.

#### Eligibility Criteria of the Bidder:

- Attested photocopies of PAN Number.

- Bid Security as specified in the Tender Document.
- One no. of ICE BOX as sample to be supplied by the bidder.
- GST clearance certificate.

#### Evaluation of the quotation:

The purchaser will evaluate and compare the quotations determined to be substantially responsive, i.e. which are properly signed and confirm to the terms and conditions, and specifications.

Tender received late and incomplete will not be considered. The bidder should sign and stamp each page of the Tender document.

#### Tender Papers Cost:

The bidder shall furnish Tender Paper Cost of Rs.1000/- (Rupees One thousand) only, in the shape of Bank Demand Draft, in favor of **District Fisheries Officer, Malkangiri**, payable at Malkangiri, which is non refundable along with quotation.

**Bid Security:**

The bidder shall furnish bid security of Rs.5,000/- (Ten thousand) only in the shape of STDR Pledged to the District Fisheries Officer, Malkangiri along with the tender as security deposit. After completion of the tender process, the amount to be refunded to the unsuccessful bidders.

The bid security of successful bidder will be refunded after supply of the required quantity to District Fisheries Officer, Malkangiri, as per the specification with the terms and conditions. The material should be supplied within 10 days of receipt of order. If the bidder fails to submit the materials within the scheduled time, the Security Deposit shall be forfeited.
