**10. GUARANTEE :**

- 10.2 Any manufacturing defects detected during the above said guarantee period shall be rectified free of cost by the supplier.

**11. LIQUIDATED DAMAGES :**

The work shall be completed within the stipulated delivery period, failing which liquidated damages for the delay @ Rs. 500/- (Rupees five hundred) only per day will be deducted from the contract value payable to the supplier and will be limited to a maximum of 5 (five) per cent of the basic value.

**Specification (19 +1 ) 20 Seater FRP/Wooden Open Boat for Ferry Use**

20 Seater FRP Boat will be constructed and built in accordance with the specifications contained herein. It will be custom-built to meet the Operational requirements of the Reservoir / River.

**1. GENERAL :**

The boat will be made of FRP (Fiberglass Reinforced Plastic) and will be designed and built or Wooden fiber coated for use as a 20 Seater boat

**MAIN DIMENSIONS :**

Length (Overall) : **8. 50 Mtrs.**  
Breadth (Overall) : **2. 50 Mtrs.**  
Depth : **1. 10 Mtrs**

**2. ENGINE :**

25 HP, 4- Stroke, Yamaha make , Out Board Engine ( Petrol) with Front Steering arrangement will be fitted at the transom of the Boat. The fuel tank (Detachable) as supplied by the Yamaha will be kept at the aft.

**3. CAPACITY :**

Passengers : 19 (Nineteen) Persons  
Crew : 01 (One) Person.

**4. MATERIAL :**

The Hull Structure will be made of FRP construction with sufficient Stringers and Girders to achieve the required impact shock resistance. It will have a round bilge at ford and chine at aft.

The thicknesses and other features of the hull are as follows:

Keel	-	9 mm
Bottom	-	7 mm
Sides	-	6 mm
Sheer	-	7 mm
Main Bulkheads (Ford & Aft)	-	12 mm marine plywood with 2mm FRP lining

**ii) SUPERSTRUCTURE ARRANGEMENT:**

The boat will have a FRP Canopy, a Wind Shield with Toughened Glass at front, rolled Canvas covering all around.

The Helmsman steering console to be given at the front.

The usable Floor area will be divided under the floor to 3(three) Water Tight Compartments for safety. Flooring of the boat is made of PVC foam sandwiched FRP and covered with poly glass mat.

Buoyancy blocks as required will also be provided using polystyrene and PU foam as the buoyancy material.

The boat will have a seating arrangement for 19(nineteen) passengers with FRP Bench at both sides. One Forward facing seat for driver.

The ford bulkhead will have a door opening to create a small store. The aft bulkhead will have the space for battery as well as Fuel tank. The cables will pass through a rubber gland and though a PVC tubing from engine to steering area.

The boat will have suitable Rubber fenders to be fitted around the boat .

3(three) nos. SS Bollards should be fitted on the deck.

All the exposed steel fittings including bollards, railings and fasteners, etc., wherever required, will be of Stainless steel 304 quality and will have good smooth surfaces.

A well should be provided at a suitable place for collection of any water from inside the boat.

**5. SAFETY, LIFE SAVING & FIREFIGHTING:**

Life Jackets-20 nos., Life Buoys-2 nos., MS Anchor-1 no. with PP Rope (dia-16mm x 10mtr)-1 no., Mooring Rope (dia-16mm x 10mtr)-2 nos., Oar- 2 nos. and Fire Extinguisher (2 kgs)-1 no. to be provided in the boat.
