SECTION – 1 (REQUEST FOR PROPOSAL)

The **Block Development Officer, Kalimela** invites sealed tender in prescribed form from reputed firms/authorized dealers/companies/agencies/registered manufacturers for the purpose of supply and installation of enlisted furniture for smart class in different high schools of Kalimela Block under 5T High School Transformation programme of Govt. of Odisha.

Brief Scope of Supply

The successful bidder will be entrusted for supply and installation of dual desk cum bench system in smart classes, chairs and stools in e-library and science laboratory and modular tables for science experiments to ensure advanced infrastructure and amenities in the smart classes and e-Library and Laboratory in various High schools run under Govt. of Odisha. This will impart smart education and ease of understanding of the poor students thereby strengthening learning ability. The expenditure towards said infrastructure shall be funded under the scheme "Mo School-5T High School Transformation", Govt. of Odisha. The brief scope of supply involves;

- I. The successful bidder will be responsible for supply including installation of furnitures, Supply and Deployment and Training, and other allied accessories.
- II. The successful bidder will be maintaining and up keeping the supplied infrastructure at each location during the project period of 1 year (on-site). The bidder has to supply, install and maintain the infrastructure in each of the locations. The bidder will be responsible for training of teachers (minimum 5) per school for 5 days within 3 Months of establishment, 2 days follow-up after 6 Months of initial training in first year.
- III. Bill of Material is detailed in Section 3.

2. Pre-Qualification Criteria

The bidder should meet the following pre-qualification criteria:

- I. The bidder must be a registered company in India, registered under the Companies Act 1956 and should be in existence since last 3 years or more. Consortium in any form is not allowed.
- II. The eligibility of the Bidder will be judged based on own or the OEMs credentials. Hence, in case of bidder is channel Partner, the respective OEM has to authorize in writing on its letter head to allow the Partner in using its credentials for eligibility.
- III. OEMs / Channel partners of OEM's can participate in this tender. For execution of orders, OEM may declare in the Manufacturer's Authorization Form) its channel partners who will be treated as supplier.
- IV. The OEMs / Channel partner's of OEM's should have presence in Odisha for last 3 (three) financial years in the same business area. Documentary evidence with self-attested is to be attached with the bid.
- V. The Bidder should have not been banned / black listed as on date by any Government Agencies / Govt. Department/ Quasi Govt Department / PSU / Board/ council or similar organization on grounds of non-performance, fraud practice, financial irregularities. A self-declaration on the letterhead of the bidder duly signed and stamped by the Authorized Signatory to be submitted.
- VI. Bidders must submit tender specific authorization from the OEM of each of the hardware items including the computing device, isolation transformer and UPS. Bids without such authorizations are liable to be summarily rejected.
- VII. All hardware items must be quoted with minimum 1 year on site comprehensive manufacturer's replacement warranty. All the Bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation and comprehensive maintenance of services during replacement warranty period.
- VIII. Tender document must be submitted along with all the relevant documents. This is required to show that the bidder had accepted all the terms and conditions mentioned in this tender document.
- IX. However, Block Authority reserves the right to evaluate the Bidder's performance through the report from any Govt. Department / Quasi Govt. Dept / PSU / Board Council or similar organization at their own discretion or ask the bidder to produce service satisfaction certificate from the customer base mentioned as per above criteria.
- X. Tender Specific Authorization Certificate for the supply, installation and maintenance during replacement warranty period from the OEM.
- XI. Technical Brochures of items quoted. Printed and published Brochure and / or Web site reference essential.
- XII. The bidder should have valid documentary proof of GST registration
- XIII. PAN registration number- Self-Certified Copy of PAN /GST registration
- XIV. The bidder should submit (self-attested) documentary proof in support of each of the above conditions. The incomplete offers will be summarily rejected without any further correspondence.

- XIV. The bidder should submit (self-attested) documentary proof in support of each of the above conditions. The incomplete offers will be summarily rejected without any further correspondence.
- XV. Bidders who will qualify basis the above criteria may be called for a technical presentation in order to evaluate the technical understanding and capability of the bidders. Tendering authority has all the rights to reject or select the bidders for further evaluation.
- XVI. Details of Tender documents will be obtained from the District website www.malkangiri.nic.in from **16.11.2023 at 10:00 AM to Dtd. 28.11.2023 by 5:00 PM** in all the working days. The cost of the tender paper of **Rs 6,000/-** for each work which is non-refundable to be submitted along with **tender paper in shape of Demand Draft in favour of Block Development Officer, Kalimela payable at SBI, Kalimela.**
- XVII. Earnest Money Deposit in shape of T.D.R/N.S.C/ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra/ Bank Guarantee pledged in-favour of BDO, Kalimela from any Nationalized/ Scheduled Bank in India counter guaranteed by its local Branch.
- XVIII. Tendering authority reserves the right to accept or reject any or all the offers without assigning any reason.
- XIX. The interested bidders to submit bids in sealed envelope superscribed with name of the work and enclosed with all tender documents as mentioned above along with tender paper cost and EMD in prescribed shape through Speed Post of Govt. of India only and the same should reach at office of the Panchayat Samiti, Kalimela of Malkangiri district as per the terms and conditions as laid down in the tender specification within scheduled date and time. Bids received beyond the scheduled date and time will not be considered for evaluation and summarily be returned to participants if any.
- XX. The exemption for submission of EMD cost should be submitted by those bidders who want to avail in writing with evidence along with tender document.
- XXI. The bidders have to present demonstration of the products during evaluation of their bids in the scheduled date at Block office, Kalimela and the 1st lowest bidder has to justify the rate and quality of the product to the Tender committee.

SECTION - 2

TERMS AND CONDITIONS

1) **Price Basis**

- a) Prices shall be quoted in Indian rupees, and shall be inclusive of all applicable taxes. The taxes will be shown separately. TDS deduction shall be made as per the prevailing Govt. Laws/ notification
- b) Bidders are requested to fill individual fields and quote the price for complete BOM, as per section-3 for each work.

2) **Validity Period of RFP**

Price quoted shall remain valid for a period of 1(One) year beyond the scheduled date of RFP submission.

3) **Insurance**

The equipment supplied vide this RFP shall be fully insured against loss or damage incidental to manufacturer or acquisition during transportation, storage, delivery and installation and handover to the tendering authority.

4) **Payment Terms:**

The supplier/ agency shall submit GST compliant bill in triplicate after successful supply, installation and commissioning of assigned work in full quantity and handing over in appropriate format. The tender committee will further be deputed for verification & certification of the work executed thereafter will be sent to competent authority for pass & Payment. Payment will be made within 45 days of submission of bill through D.D/Cheque. The bank charges for D.D/B.C have to be borne by the Contractor. TDS on IT and GST and labour cess as applicable will be deducted from the payable. The payment will be made in final bill only. No Advance payment shall be made in any case.

5) **Delivery Schedule**

The entire consignment must be completed within delivery period of 15 (fifteen) days from the date of purchase order. Any delay beyond this period may be liable for penalty as per codal provision of OPWD, Govt. of Odisha.

6) **Penalty**

In case of delay in project implementation, the penalty would be applied by the tender inviting authority.

7) **Warranty**

The period of warranty on all supplied equipment's shall be minimum 01 (one) year or warranty as offered by the manufacturer whichever is higher.

8) **Submission of bids**

The bids have to be submitted in physical form at BDO Kalimela with technical cum Pre-qualification bid & price bid duly filled inside the envelop superscribed with name of the work & name of bidder on it.

9) Evaluation of Bids

- a) Tendering authority shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise. Tendering authority shall carry out detailed evaluation of the substantially responsive bids. Tendering authority shall check the bid to determine whether they are complete, whether any computational errors have been made or required sureties have been furnished.
- b) Arithmetical error shall be rectified on the following basis
 - I. If there is a discrepancy between the unit price and total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Purchaser.
 - II. In case of discrepancy between words and figures, the amount in words shall prevail
 - a. A bid determined as substantially non-responsive shall be rejected by the purchaser.
 - b. TENDERING AUTHORITY may waive any minor infirmity or non-conformity or irregularity in the bid which does not constitute a material/service deviation.
 - c. TENDERING AUTHORITY shall evaluate in detail and compare the bids which are substantially responsive.
 - d. Total Cost of Hardware, Software fixing and Services inclusive of all taxes (As asked as point C in Financial bid format) will be compared among all responsive bids and lowest bidder i.e., L1 will be sought supply order with stipulated terms and conditions in compliance with tender specification.

10) GST Registration:

The bidder must give a declaration mentioning that they will take the state GST registration in the state of work.

11) Termination of Default

BLOCK TENDER COMMITTEE may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the contractor, terminate this contract in whole or in part.

- a. if the contractor fails to deliver any or all the services/goods within the time period specified in the contract, or any extension thereof granted by BLOCK TENDER COMMITTEE.
- b. if the contractor fails to perform any other obligation(s) under the contract; and
- c. if the contractor, in either of the above circumstances, does not remedy his failure within a period of 15 days (or such longer period as the purchaser may authorize in writing) after receipt of the default notice from BLOCK TENDER COMMITTEE.
- d. In the event BLOCK TENDER COMMITTEE terminates the contract in whole or in part pursuant to above clause, BLOCK TENDER COMMITTEE may procure, upon such terms and in such manner as it deems appropriate, goods/services similar to those undelivered and the contractor shall be liable to BLOCK TENDER COMMITTEE for any excess cost for such similar goods/services.


However, the contractor shall continue the performance of the contract to the extent not terminated.

12) Blacklisting. The firm shall be black-listed, if it is found that:-

- i) Forged documents are submitted OR
- ii) If it becomes responsive on the basis of submission of bogus certificate/information. OR
- iii) In case of non-supply of materials or supply of substandard quality or supply of materials found to have been previously used or having reconditioned parts.

13) Bidder shall not have been debarred/black listed by the central Govt./state Govt./ Public sector undertaking/any other Local body. If in future, it comes/brought to the notice of The BLOCK TENDER COMMITTEE, during the tenure of this contract, that any disciplinary/penal action is taken against the bidder due to violation of terms and conditions of the tender allotted to Bidder. The bidders / manufactures which amounts to cheating/depicting of amplified intention anywhere in The BLOCK TENDER COMMITTEE, KALIMELA or either by any of central Govt./state Govt./Public sector undertaking/any other Local body, The BLOCK TENDER COMMITTEE, KALIMELA will be at discretion to take appropriate action as it finds fit.

14) All the above conditions should be strictly adhered to failing which the tender will be treated as non-responsive and no correspondence will be entertained in the matter.
