The Tender applications received by due date and time will be opened on **02.12.2023** at **11.00 A.M** in presence of Tender Committee and Tenderers and/or their authorized representatives under the chairmanship of Block Development Officer, Malkangiri.

Brief Scope of Supply

BDO Malkangiri would like to provide advanced infrastructure in the field of IT and Computer Science as E- Libraries are there in High Schools being transformed under 5T initiative of Govt. of Odisha. This will help to impart Teaching in a ease of understanding of the students leading to strengthening learning ability. The expenditure towards said Infrastructure up gradation /development shall be funded under the scheme "Mo School Abhiyan-5T High School Transformation Initiative", Govt. of Odisha.

In this regard, BDO Malkangiri is inviting the OEMs/ Authorised Dealers/Reputed Firms/ Companies/Agencies who are ready to supply the required apparatus /digital equipments and extend services to us as per Terms & Conditions defined in such Tenders. The brief scope of supply involves:

- I. The Apparatus/Digital Equipments are to be procured on item-rate contract basis as per provisions stipulated in various clauses of OPWD. The successful bidders will be responsible for supply, installation and commissioning under scope of supply including maintenance of all components for the desired guarantee/warranty period.
- II. The successful bidder will have to maintain and up keep the supplied / installed/Commissioned Apparatus/Digital Equipments at specified location for a minimum project period of 03 (Three) years.
- III. To impart Training to teachers/students at targeted schools for operation and maintenance of installed/commissioned apparatus/ Digital Equipments.
- IV. The scope of supply item wise is detailed in Part 3.

Pre-Qualification Criteria

The bidder should meet the following pre-qualification criteria:

- I. The bidder must be a registered company in India/MSMEs should be in existence since last 3 years or more. Any Consortium in any form is not allowed.

- II. The eligibility of the Bidder will be judged based upon the OEMs credentials. Hence, in case of a bidder happens to be a channel partner, the respective OEM has to authorize in writing on its letter head to allow the Partner to use its credentials for eligibility.
- III. OEMs / Channel partners of OEMs' can participate in this Tender process. For execution of orders, OEM may declare in the Manufacturer's Authorization Form) as its channel partners who will be treated as supplier.
- IV. The OEMs / Channel partners of OEM's should have presence in Odisha for last 3 (three) Financial Years in the same business area. Documentary evidence with self-attestation is to be attached with the Bid documents.
- V. The Bidder should have not been banned / black listed as on the date of BID opening by any Government Establishment / Govt. Department/ Quasi Govt Department / PSU / Board/ Council or similar Organization on grounds of non-performance, fraud practice, financial irregularities. A self declaration on the letterhead of the bidder duly signed and stamped by the Authorised Signatory required to be submitted.
- VI. Bidders must submit tender specific authorization from the OEM for each of the hardware items including the Computing Device, keyboard and optical mouse with name, address and e-mail ID of the inc. signatory. Bids without such authorizations are liable for rejection summarily.
- VII. All Hardware items must be quoted with minimum 03 (Three) year on site comprehensive manufacturer's replacement warranty/Guarantee. All the Bidders should produce a certificate from the OEMs regarding their acceptance of responsibility of supply, installation, commissioning and comprehensive maintenance of services during replacement warranty/Guarantee period.
- VIII. Signed copy of Tender document must be submitted along with all the relevant documents. This is required to show that the bidder has accepted all the Terms and Conditions mentioned in this Tender Document.
- IX. However, Block Authority reserves the right to evaluate the Bidder's performance through the report from any Govt. Establishment/Department / Quasi Govt. Dept / PSU / Board/ Council or similar Organization at their own discretion or will ask the bidder to produce Service Satisfaction Certificate from the Customer base mentioned as per above criteria.
- X. The Bidder should submit Tender Specific Authorization Certificate for supply, installation, commissioning and maintenance during replacement warranty period from the OEM.
- XI. The Bidder should submit Technical Brochures of items quoted. Printed and published Brochure and / or Web site reference is essential.
- XII. The bidder should submit self-attested copy of valid GST registration & IT PAN registration certificate. The GST shall be registered in the name of Bidder. The IT PAN registered in the name of Proprietor are also admissible.
- XIII. The Bidder shall submit ISO 9001, 14001, ISO 27001 & ISO 20001 for OEM certificate.
- XIV. The bidder should submit (self-attested) documentary proof in support of each of the above conditions. The incomplete Bid offers will be summarily rejected without any further correspondence.
- XV. The Bidders who will qualify on fulfilling the above criteria may further be called for a technical presentation in order to evaluate the technical understanding and capability of the bidders. Tendering authority shall have all rights to reject or select the bidders for further evaluation.
- XVI. **Sale of Tender papers:-** Bid documents consisting, the schedule of quantities and the set of Terms and Conditions of contract and other necessary documents can be accessed in the Govt. website www.malkangiri.nic.in from 21.11.2023 to 01.12.2023 . No Tender paper will be sold at the Panchayat

- XVII. The bidders have to submit bid having tender paper cost of requisite amount in shape of Demand Draft/ Banker's cheque in favour of BDO, Malkangiri from any Nationalized/ Scheduled Banks of India payable at SBI, MALKANGIRI.
- XVIII. Tendering Authority reserves the right to accept or reject any or all the offers without assigning any reason thereof.
- XIX. The Bid Application required to be submitted to the BDO, Malkangiri, Malkangiri District as per the Terms and Conditions as laid down in the tender specification.

PART - 2
TERMS AND CONDITIONS

1) Price Basis

- a) Prices shall be quoted in Indian rupees, and shall be inclusive of all applicable taxes. The taxes will be shown separately. TDS deduction shall be made as per the prevailing Govt. Laws/ Notifications.
- b) Bidders are requested to quote the price for complete BOM (Bill of materials) as mentioned in Part-3.

2) Validity Period of Tender

Price quoted shall remain valid for a period of **90 (Ninety) days** from the scheduled date of Bid submission.

3) Insurance

The equipment supplied vide this this Tender shall be fully insured against loss or damage incidental to manufacturer or acquisition during transportation, storage, delivery and installation and handover to the tendering authority

4) Payment Terms: No Advance payment shall be made in any case. 95% payment of total Bill shall be made released/ paid after successful Installation and commissioning of Desktop Computers in all respect as per scope of supply and certification of the Engineer-in-Charge. However, 5% of remaining bill shall be released/paid after completion of 03(Three) years of warranty/Guarantee Period provided satisfactory repair/maintenance/servicing of Installed/Commissioned Desktop Computers during warrantee/Guarantee Period.

5) Delivery Schedule

The complete setup shall need to be installed and commissioned at site within **10 (Ten) days** from the date of written order for commencement of work/supply.

6) Penalty

In case of delay in supply/commissioning/installation of Desktop Computers, the penalty would be imposed by the Tendering Authority as per codal provisions of OPWD.

7) Warranty/Guarantee

The period of Warranty/Guarantee on all supplied equipment's shall be minimum 03(Three) years. Any repair/replacement, if required during the Warranty/Guarantee Period shall be provided by the supplier at his own cost and without any financial liability to this office.



8) Submission of Bids

The Bids have to be submitted in physical mode/ form to the BDO Malkangiri with Technical cum Pre-qualification Bid in one envelope and Financial Bid in another envelope. Both the envelopes should be kept in another Bigger size envelope with the name of the bidder & the Name of the work should be super scribed in Capital Letters on the envelope.

9) Evaluation of Bids

- a) Tendering Authority shall evaluate the bids in respect to the substantive responsiveness of the bid or otherwise. Tendering Authority shall carry out detailed evaluation of the substantially responsive bids. Tendering Authority shall check the bid to determine whether they are complete, whether any computational errors have been made and required any sureties have been furnished or not.
- b) Any Arithmetical error shall be allowed for rectification on following basis
 - I. If there is a discrepancy between the Unit price and Total price that is obtained multiplying the unit price and quantity, the unit price shall prevail and the total price shall be allowed for correction by the Purchaser.
 - II. In case of discrepancy between words and figures, the amount in words shall prevail upon.
- c) A bid determined as substantially non-responsive shall be rejected by the Tendering Authority.
- d) TENDERING AUTHORITY may waive any minor infirmity or nonconformity or irregularity in the bid which does not constitute a material/service deviation.
- e) TENDERING AUTHORITY shall evaluate in detail and compare the bids which are substantially responsive.
- f) Total Cost of Hardware, Software fixing and Services inclusive of all taxes will be considered for the evaluation of L1 bidder

10) GST Registration:

The bidder must have valid GST Registration during submission of Bid.


11) Termination of Default

BLOCK TENDER COMMITTEE may, without any prejudice to any other remedy for breach of contract, by written notice of default, sent to the contractor, terminate this Bid in whole or in part.

- a. if the Bidder/Supplier fails to deliver any or all the services/goods within the time period specified in the supply order, or any extension thereof granted further by BLOCK TENDER COMMITTEE
- b. if the Bidder fails to perform any other obligation(s) under the contract and
- c. if the Bidder, in either of the above circumstances, does not take remedial measure to comply his failure within a period of 07(Seven) days (or such longer period as the Bid Authority may authorize in writing) after receipt of the Default Notice from BLOCK TENDER COMMITTEE.
- d. In the event BLOCK TENDER COMMITTEE terminates the contract in whole or in part pursuant to above clause, BLOCK TENDER COMMITTEE may procure, upon such Terms and Conditions in such manner as it deems appropriate, Goods/Services similar to those undelivered and the Bidder shall be liable to BLOCK TENDER COMMITTEE for any excess cost for such similar Goods/Services. However, the Bidder shall continue the performance of the Bid to the extent not terminated.

12) Blacklisting. The firm shall be black-listed, if it is found that:-

- i) Forged documents are submitted OR
- ii) If it becomes responsive on the basis of submission of bogus/and false certificate/information. OR

A handwritten signature in green ink, followed by the date '20/11/20' written vertically.

- iii) In case of non-supply of materials or supply of substandard quality or supply of materials found to have been previously used or having reconditioned parts.
- 13) Bidder shall not have been debarred/black listed by The Central Govt./State Govt./ Public Sector Undertaking/any other Local Body. If in future, it is known/brought to the notice of The BLOCK TENDER COMMITTEE, during the tenure of this contract, that any disciplinary/penal action is taken against the bidder due to violation of Terms and Conditions of the any tender allotted to the Bidder. The Bidders / Manufactures who are amounts to cheating/depicting of amplified intention anywhere in The BLOCK TENDER COMMITTEE, MALKANGIRI or either by any of Central Govt./State Govt./Public Sector Undertaking/any other Local body, The BLOCK TENDER COMMITTEE, MALKANGIRI will be at discretion to take appropriate action as it deems fit.
- 14) The quantity as detailed in the scope of supply may exceed to the extent of 100% for **one Calendar year** to the discretion of administrative power accorded by the Tender Inviting Authority as the case deemed fit. In case of excess requirement, a separate supply order will be issued to the successful Bidder with due intimation.
- 15) All the above conditions should be strictly adhered to failing which the tender will be treated as non-responsive and no correspondence will be entertained in the matter.'
- 16) In case of any dispute, the decision of the Block Development Officer, Malkangiri is final.
- 17) If any legal dispute arises, the Jurisdiction of the matter is limited /subjected within Malkangiri District only.


