1. In Sl.No.9 (INFORMATION FOR THE INTENDING BIDDERS) regarding "If the % rate quoted by any bidder for the work is **more** than or equal to 15% less (-), then such bid shall be rejected and the tender shall be finalized based on merits of the remaining bids. But, if more than one bid is quoted at 14.99% (decimals up to two numbers will be taken for all practical purposes) less, the tender shall be finalised through a transparent lottery system where, all such bidders/ their authorised representatives may remain present.
