### **Tender Call Notice for Wall Painting at GP Level**

Sealed Tender is hereby invited by the District Fisheries Officer, Malkangiri from the intending bidders / reputed firms for Wall Painting on Fisheries Programme at 111 Gram Panchayat of Malkangiri District. The Tender documents must be submitted through registered post/ Speed Post service latest by 29.12.2023, 5.30 PM and the Tender will be opened on 30.12.2023 at 11.30 AM in the Office chamber of Dist. Fisheries Officer, Malkangiri. The Tender should reach in Sealed cover with supers cribbing with "Tender for Wall Painting under IEC schemes of District Fisheries Officer, Malkangiri."

#### **ELIGIBILITY CRITERIA: (SELF ATTESTED DOCUMENTS REQUIRED TO BE SUBMITTED)**

1. The bidder must be a registered Firm/ Partnership firm/Sole Proprietorship firm.
2. The bidder must have valid GST registration certificate.
3. The bidder must have a valid PAN.
4. The bidder must have a local office in state of Odisha. Proof of address must be attached.
5. The bidder should have an average minimum turnover of Rs. 50 Lakh in last three years (i.e. FY 20-21, FY 21-22, FY 22-23). The bidder must submit annual turnover certificate of last three financial year (FY 20-21, FY 21-22, FY 22-23) duly certified by C.A (Annexure – II).
6. Minimum 2 years of experience in Wall painting in Govt. / PSUs (Work order to be furnished)
7. The bidder must not have been barred or blacklisted by any State/ Central Government Departments/ Govt. Agencies or any PSUs (A declaration to this effect shall be furnished).
8. The Tender document should accompany with Profile of the Agency as Bidders profile (Annexure – I) and Financial Bid (Annexure-III)
9. The assignment period shall be for 2 years from the date of the work order. The assignment period may be extended basing on the satisfactory performance and need of the Authority

10. The tender document shall accompany with an EMD of Rs. 20,000/- (Twenty Thousand) with at which the tender shall be related. The EMD should be in favour of District Fisheries Officer, Malkangiri in form of DD. EMD may be forfeited if they withdraw or modified their tender/violet the terms & conditions of Tender.
11. The Payment to the agency on the assignment will be made by assigning authority / office for the delivers submitted by the agency and as per the approved rates of the Dist. Fisheries Officer, Malkangiri after successful completion of the assignment along with the GST bill.
12. The EMD value appropriate 20000/- shall be retained till completion of the assignment and releasing of full and final payment. The EMD shall returned to the agency after successful completion of the assignment.
13. The selected Agency should complete the Wall painting within 15 days from the issue of work order.
